TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("**Trademark Assignment**"), dated as of August 31, 2020, is made by Gogo LLC, a Delaware limited liability company, located at 111 N. Canal Street, Chicago, Illinois 60606 ("**Assignor**"), in favor of Gogo Business Aviation LLC, a Delaware limited liability company, located at 105 Edgeview Drive, Suite 300, Broomfield, Colorado 80021 ("**Assignee**"), the purchaser of certain assets of Assignor pursuant to the Intellectual Property Assignment Agreement between Assignee and Assignor dated as of August 3, 2020 (the "**Intellectual Property Assignment Agreement**").

WHEREAS, under the terms of the Intellectual Property Assignment Agreement, Assignor has conveyed, transferred, and assigned to Assignee, among other assets, certain intellectual property of Assignor, and has agreed to execute and deliver this Trademark Assignment, for recording with the United States Patent and Trademark Office and corresponding entities or agencies in any applicable jurisdictions;

NOW THEREFORE, the parties agree as follows:


1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest in and to the trademark registrations set forth on Schedule 1 hereto and all issuances, extensions, and renewals thereof (the "**Assigned Trademarks**"), together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks; provided that, with respect to the United States intent-to-use trademark applications set forth on Schedule 1 hereto, the transfer of such applications accompanies, pursuant to the Intellectual Property Assignment Agreement, the transfer of Assignor's business, or that portion of the business to which the trademark pertains, and that business is ongoing and existing. .

2. Terms of the Intellectual Property Assignment Agreement. The parties hereto acknowledge and agree that this Trademark Assignment is entered into pursuant to the Intellectual Property Assignment Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Assigned Trademarks. The representations, warranties, covenants, agreements, and indemnities contained in the Intellectual Property Assignment Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Intellectual Property Assignment Agreement and the terms hereof, the terms of the Intellectual Property Assignment Agreement shall govern.

3. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.
