SHORT-FORM ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of September 1, 2020 (the "Effective Date") by and between Dell Inc., a Delaware corporation ("Dell"), EMC Corporation, a Massachusetts corporation ("EMC") and RSA Security LLC, a limited liability company formed under the laws of the State of Delaware ("Assignee") (each a "Party" and collectively, the "Parties").

WHEREAS, this Assignment is entered into in connection with that certain Securities and Asset Purchase Agreement (the "Purchase Agreement"), dated as of February 18, 2020, by and between Redstone Buyer, LLC, a Delaware limited liability company, and Dell Technologies Inc., a Delaware corporation;

WHEREAS, in connection with the Purchase Agreement, the parties to the Purchase Agreement desire that Dell and EMC (each an "Assignor" and together the "Assignors"), and Assignors desire to, transfer to Assignee all of the right, title and interest of each Assignor, including all of the right, title and interest possessed by Assignors' predecessors in interest, in and to the Trademarks set forth on Attachment A attached hereto (the "Assigned Trademarks"); and

WHEREAS, Assignee wishes to acquire all of Assignors' right, title and interest in and to the Assigned Trademarks, and each Assignor wishes to assign such right, title and interest in and to such Assigned Trademarks to Assignee.

NOW, THEREFORE, in consideration of the premises and the representations, warranties, covenants and agreements contained in this Assignment, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the Parties hereby agree as follows:

1. Additional Defined Terms. Capitalized terms used but not defined in this Assignment have the meanings set forth in the Purchase Agreement.

2. Transfer of Assigned Trademarks. Pursuant to and subject to the terms and conditions of the Purchase Agreement, each Assignor does hereby sell, transfer, convey, assign and deliver to Assignee, and Assignee does hereby unconditionally (subject to Article 7 of the Purchase Agreement) purchase, acquire and accept all of such Assignor's right, title and interest, as of the date hereof, in and to the Assigned Trademarks, including all common law rights associated therewith, together with the goodwill of the Business connected therewith and the portion of the Business associated therewith, which is a going business, and together with the rights as applicable (a) to collect all future royalties and other payments with respect to any of the foregoing; (b) to sue and recover damages and obtain equitable relief and other remedies for past, current and future infringement of the Assigned Trademarks; (c) to prosecute, register, maintain, enforce and defend such Assigned Trademarks before any public or private agency, office or registrar; and (d) to fully and entirely stand in the place of such Assignor, in all matters related to the Assigned Trademarks. Each Assignor hereby authorizes and requests the Director of the United States Patent and Trademark Office and the empowered officials of all other governments to transfer the Assigned Trademarks to Assignee, as assignee of the entire interest thereto and to record Assignee as the

assignee and owner of the Assigned Trademarks and to deliver to Assignee, and to Assignee's attorneys or agents, all official documents and communications as may be warranted by this Assignment. For the avoidance of doubt, and notwithstanding the Seller Disclosure Schedules or anything in this Assignment to the contrary (including Section 9), the Parties hereby acknowledge and agree that the Assigned Trademarks constitute Transferred Owned IP for purposes of the Purchase Agreement.

3. Disclaimer. WITHOUT LIMITING ANY REPRESENTATION, WARRANTY OR COVENANT SET FORTH IN THE PURCHASE AGREEMENT OR ANY AGREEMENTS ENTERED INTO PURSUANT TO OR IN CONNECTION WITH THE PURCHASE AGREEMENT, ASSIGNORS MAKE NO REPRESENTATION OR WARRANTY, EXPRESS OR IMPLIED, AT LAW OR IN EQUITY, IN RESPECT OF THE ASSIGNED TRADEMARKS, INCLUDING, WITHOUT LIMITATION, WITH RESPECT TO MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE, AND ANY SUCH OTHER REPRESENTATIONS OR WARRANTIES ARE HEREBY EXPRESSLY DISCLAIMED.

4. Further Assurances. Subject to Section 5.8(c) of the Purchase Agreement, each Assignor shall cooperate and take all actions reasonably necessary to carry out the provisions and purposes of this Assignment and the transactions contemplated hereby, including, without limitation, any actions Assignee may reasonably deem necessary in order to transfer, convey, assign and deliver to Assignee, and to confirm Assignee's right, title and interest in and to, the Assigned Trademarks.

5. Entire Agreement. This Assignment, and the Purchase Agreement, reflect the entire understanding of the Parties relating to the sale, assignment, transfer, conveyance and delivery of the Assigned Trademarks from Assignors to Assignee, and supersedes all prior agreements, understandings or letters of intent between or among the Parties regarding the subject matter of this Assignment and the Purchase Agreement.

6. Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns.

7. Governing Law. This Assignment shall in all respects be governed by, and construed in accordance with, the Laws of the State of Delaware (excluding conflict of laws rules and principles, to the extent that to do so would result in the application of the Laws of another jurisdiction) applicable to agreements made and to be performed entirely within such State, including all matters of construction, validity and performance.

8. Execution in Counterparts. This Assignment may be executed by facsimile or PDF signatures and in any number of counterparts with the same effect as if all signatory parties had signed the same document. All counterparts shall be construed together and shall constitute one and the same instrument.

9. Purchase Agreement Shall Control. Nothing in this Assignment shall modify the terms or conditions of the Purchase Agreement and nothing contained in this Agreement shall be deemed to supersede, modify, limit, extend, add to, amend or in any way affect any rights or obligations of Assignors or Assignee arising under the Purchase Agreement. In the event of a

conflict or controversy between the terms of this Assignment and the Purchase Agreement, the terms of the Purchase Agreement shall control.
