TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of September 3, 2020, by Antares Capital LP, in its capacity as collateral agent for the Secured Parties (in such capacity and any successor in such capacity, the “Collateral Agent”), in favor of Valet Living, LLC (the “Pledgor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Pledgor and Collateral Agent are party to (i) that certain Intellectual Property Security Agreement dated as of September 28, 2018, which was recorded by the United States Patent and Trademark Office on October 1, 2018, at Reel 6485, Frame 0626 (the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, Pledgor has granted a security interest in certain Intellectual Property Collateral as security for certain obligations owing by Pledgor to Collateral Agent, including the Trademark Collateral set forth on Schedule A annexed hereto;

WHEREAS, Pledgor has requested that Collateral Agent release its security interest in the Trademark Collateral and reassign any and all rights in the same to Pledgor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Collateral Agent hereby releases and terminates its Lien on and security interest in all of Pledgor’s right, title and interest in, to and under the following Collateral of Pledgor (collectively, the “Trademark Collateral”):

all of its Trademarks and IP Licenses providing for the grant by or to such Pledgor of any right under any Trademark, including, without limitation, the Trademarks referred to on Schedule A;

all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, violation or other impairment thereof.

Collateral Agent hereby reassigns, grants and conveys to Pledgor, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent’s right, title and interest in and to the Trademarks and the Trademark Collateral.
