**TERMINATION AND RELEASE OF
SECURITY INTEREST**


This Termination and Release of Security Interest in Collateral ("**Release**") is made and entered into as of August 24 2020 by The Prudential Insurance Company of America, a New Jersey corporation having an address of 2100 Ross Avenue, Suite 2500, Dallas, TX 75201 ("**Lender**"), in favor of Ferrari-Carano Vineyards and Winery LLC, a California limited liability company and their assigns (collectively, "**Borrower**").

WHEREAS, pursuant to that Collateral Assignment of Trademark entered into as of January 1, 2002 ("**Security Agreement**") by and among Borrower and Lender, Borrower granted and assigned to Lender a security interest in and lien on certain interests in the trademark FERRARI-CARANO (U.S. Reg. No. 1,634,300) and related collateral as defined in the Security Agreement (collectively, "**Trademark**"), which Security Agreement was duly recorded with the United States Patent and Trademark Office on February 11, 2002, at Reel: 002450 Frame: 0001 and Reel: 002450 Frame: 0312.

WHEREAS, Borrower has satisfied all of its obligations to Lender under the Security Agreement, and Lender now wishes to terminate the Security Agreement, release its security interest and lien, and retransfer, and reassign to Borrower all of Lender's right, title and interest in the Trademark.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Lender hereby unconditionally and irrevocably terminates the Security Agreement, terminates and releases its security interest in and lien on the Trademark, and Lender hereby reassigns to Borrower, without warranty or recourse, all of Borrower's right, title, and interest in and to the Trademark.
