RELEASE OF TRADEMARK SECURITY INTEREST

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Silicon hereby relinquishes unto Intellicheck the continuing security interest in and lien on the “Collateral” as defined in the Security Agreement, and otherwise assigns, grants and conveys to Intellicheck any and all rights Silicon may have in or to the Collateral of the Security Agreement in order to revest in Intellicheck full title to said Collateral.

Silicon hereby represents and warrants that it has not assigned any interest in the Collateral and has the unqualified right to enter into this release and perform its terms.
