NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby terminates the Agreements and releases, retransfers and reassigns to Grantor without representation or warranty, any and all liens, security interests, right, title and interest of Agent in and to the Marks and the goodwill associated therewith.
