ACKNOWLEDGMENT OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, MOBILEHELP, LLC, a Delaware limited liability company (formerly known as INTEGRITY TRACKING, LLC, a Pennsylvania limited liability company) ("Grantor"), holds all right, title and interest in and to the Trademarks (as such term is defined under the Collateral Agreement referenced below), including the trademarks and service marks listed on the attached Schedule 1 (the "Trademark Collateral");

WHEREAS, Grantor has entered into a Guaranty and Collateral Agreement (as amended, restated, supplemented or otherwise modified from time to time in accordance with its terms, the "Collateral Agreement"; all terms used but not otherwise defined herein shall have the meanings set forth in the Collateral Agreement) dated as of February 22, 2017, by and among Grantor, certain other credit parties from time to time party thereto, and FMP Agency Services, LLC, in its capacity as agent (the "Agent"); and

WHEREAS, pursuant to the Collateral Agreement, Grantor has granted to the Agent, for the benefit of the Secured Parties, a continuing security interest in all right, title and interest of Grantor in, to and under the Trademark Collateral (excluding in each case any Trademarks that constitute Excluded Property as that term is defined in the Collateral Agreement), the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby grant to the Agent, for the benefit of the Noteholders, a continuing security interest in the Collateral as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Secured Obligations.

Grantor does hereby further acknowledge and affirm that the rights and remedies of the Agent with respect to the Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms hereof and the terms set forth in the Collateral Agreement, the terms set forth in the Collateral Agreement shall govern.


