**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of June 14, 2019 by **SILICON VALLEY BANK** (the “**Bank**”), in favor of the Grantors (as defined in the Agreement).

WHEREAS, Grantors executed and delivered a Trademark Security Agreement, dated as of May 22, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “**Agreement**”), granting the Bank a security interest in and lien on certain trademarks and trademark applications (“**Trademarks**”) described therein, which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on May 22, 2015, at Reel 5522, Frame 0539;

WHEREAS, Grantors have requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantors in, to and under all of the Trademarks as herein provided; and

WHEREAS, Grantors have requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank’s security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges all liens and security interests in Grantors’ right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
