INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement, dated as of September 18, 2020, is made by **GH PAY BUYER, INC.**, a Delaware corporation ("**Holdings**"), **ONE, INC. SOFTWARE CORPORATION**, a Delaware corporation ("**One Inc. DE**"), **ONE, INC.**, a Nevada corporation ("**One Inc. NV**"), and **INVENGER TECHNOLOGIES, INC.**, a California corporation ("**Invenger**"; together with Holdings, One Inc. DE, and One Inc. NV, collectively, "**Grantor**") in favor of **SILICON VALLEY BANK**, as administrative agent (together with its permitted successors, in such capacity, the "**Administrative Agent**") for the banks and other financial institutions or entities (each a "**Lender**" and, collectively, the "**Lenders**") from time to time parties to that certain Credit Agreement, dated as of September 18, 2020 (as amended, restated, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time, the "**Credit Agreement**"), Holdings, One Inc. DE, the Lenders party thereto and the Administrative Agent.

RECITALS

The Administrative Agent and the Lenders have agreed to make certain advances of money and to extend credit to Borrower (the "**Loans**") in the amounts and manner set forth in the Credit Agreement. The Administrative Agent and the Lenders are willing to make the Loans to Grantor, but only upon the condition, among others, that Grantor shall grant to the Administrative Agent a security interest in certain copyrights, copyright licenses, trademarks, trademark licenses, patents and patent licenses to secure the Obligations of Grantor under the Credit Agreement and the other Loan Documents. Capitalized terms used but not otherwise defined herein shall have the respective meanings given to them in the Credit Agreement.

Pursuant to the terms of the Guarantee and Collateral Agreement, Grantor has granted to Administrative Agent a security interest in all of Grantor's right, title and interest, whether presently existing or hereafter acquired, in, to and under all of the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, as collateral security for the prompt and complete payment when due of its Obligations under the Credit Agreement and the Loan Documents, Grantor hereby represents, warrants, covenants and agrees as follows:

AGREEMENT

To secure its Obligations under the Credit Agreement and the other Loan Documents, Grantor grants and pledges to Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in all of Grantor's right, title and interest in its Intellectual Property (including without limitation those copyrights, copyright licenses, patents, patent licenses, trademarks and trademark licenses listed on Exhibits A, B and C hereto), and including without limitation all proceeds thereof, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.

This security interest is granted in conjunction with the security interest granted to Administrative Agent under the Guarantee and Collateral Agreement. The rights and remedies of

Administrative Agent with respect to the security interest granted hereby are in addition to those set forth in the Credit Agreement, the Guarantee and Collateral Agreement and the other Loan Documents, and those which are now or hereafter available to Administrative Agent or any Lender as a matter of law or equity. Each right, power and remedy of Administrative Agent provided for herein or in the Credit Agreement or any of the other Loan Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Administrative Agent of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Credit Agreement or any of the other Loan Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Administrative Agent, of any or all other rights, powers or remedies.

Upon the Discharge of Obligations, the security interest in all of Grantor's right, title and interest in its Intellectual Property shall be automatically released, this Intellectual Property Security Agreement shall terminate, and all obligations (other than those expressly stated to survive such termination pursuant to the Loan Documents) of the Grantor to the Administrative Agent hereunder shall terminate, all without delivery of any instrument or performance of any act by any party. At the sole expense of the Grantor following any such termination, the Administrative Agent shall deliver such documents as the Grantor shall reasonably request to evidence such termination.

THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
