RELEASE OF SECURITY INTEREST IN TRADEMARKS

March 22, 2019

WHEREAS, FURSTPERSON, INC., an Illinois corporation ("Debtor"), granted a security interest in and lien upon certain trademarks and related rights of Debtor to STONEGATE CAPITAL HOLDINGS, INC. WHEREAS, Debtor has requested that Existing Secured Party release its interest in the trademarks of Debtor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Existing Secured Party hereby:

Releases any and all liens, security interests, right, title and interest of Existing Secured Party (as assignor of Original Secured Party) granted pursuant to the Security Agreement in the trademarks of Debtor without recourse or representation or warranty, express or implied, of any kind, including without limitation, those Trademarks set forth on Schedule A attached hereto;

Agrees that any power of attorney or similar rights granted by Debtor to Existing Secured Party (as assignor of Original Secured Party) under the Security Agreement is terminated; and

Authorizes and requests that the USPTO note and record the existence of the release hereby given.
