
Pursuant to Title 8, Sections 252 and 264(c) of the Delaware General Corporation Law and Title 6, Section 18-209 of the Delaware Limited Liability Company Act, the undersigned corporation executed the following Certificate of Merger and certifies the following information relating to the merger of The Noerr Programs Corporation, a California corporation and Holiday Photography LLC, a Delaware limited liability company, with and into Cherry Hill Programs, Inc., a Delaware corporation (the "Merger"):

1. The name of the surviving corporation is Cherry Hill Programs, Inc., a Delaware corporation (the "Surviving Corporation").
2. The name of the foreign corporation being merged into the Surviving Corporation is The Noerr Programs Corporation, a California corporation.
3. The name of the domestic limited liability company being merged into the Surviving Corporation is Holiday Photography LLC, a Delaware limited liability company.
4. The Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent entities.
5. The name of the surviving corporation is Cherry Hill Programs, Inc., a Delaware corporation.
6. The Certificate of Incorporation of the Surviving Corporation shall be its Certificate of Incorporation.
7. The authorized stock of the non-Delaware corporation is 100,000.
8. The merger is to become effective on October 31, 2019.
9. The Agreement and Plan of Merger is on file at 4 E. Stow Road, Marlton, New Jersey 08053, the place of business of the Surviving Corporation.
10. A copy of the Agreement and Plan of Merger will be furnished by the Surviving Corporation on request, without cost, to any stockholder of any constituent corporation or member of any constituent limited liability company.
