**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of September 4, 2020 (this “**Release**”), is made by **CORTLAND CAPITAL MARKET SERVICES LLC**, as collateral agent for the Secured Parties (in such capacity, the “**Collateral Agent**”), in favor of **CAPSILON CORPORATION**, a Delaware corporation (the “**Grantor**”). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Supplement (as defined below), or if not defined therein, in the Security Agreement (as defined below) or the IP Security Agreement (as defined below), as applicable.

**WITNESSETH**

WHEREAS, the Grantor and the Collateral Agent are parties to that certain Second Lien Security Agreement dated as of April 17, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) and that certain Intellectual Property Security Agreement, dated as of April 17, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**IP Security Agreement**”);

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered that certain Second Lien Trademark Security Agreement Supplement, dated as of November 1, 2019 (the “**Trademark Security Supplement**”), which was recorded with the United States Patent and Trademark Office on November 3, 2019, at Reel/Frame No. 6786/0074;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Supplement, the Grantor granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to all of the Grantor’s right, title and interest in and to the following, except for any Excluded Property (the “**Trademark Collateral**”): (i) the trademark and service mark registrations and applications set forth in Schedule A hereto, together with the goodwill symbolized thereby; (ii) all reissues, divisionals, continuations, continuations-in-part, extensions, and reexaminations of any of the foregoing, renewals, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto; (iii) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages and injunctive relief; and (iv) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Trademark Collateral or arising from any of the foregoing; and

WHEREAS, the Grantor has requested the Collateral Agent to, and the Collateral Agent now desires to, terminate and release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without recourse, representation, warranty,

promise, undertaking (other than the undertakings agreed to in this Release), statement or assurance of any kind or nature, and at the Grantor's sole cost and expense, hereby terminates, cancels and releases its security interest in the Trademark Collateral, and hereby reassigns to the Grantor any right, title or interest it may have in the Trademark Collateral.

The Collateral Agent authorizes and requests that the Commissioner of Trademarks and any other applicable government officer record this Release at the Grantor's sole cost and expense.


The Collateral Agent hereby agrees, at the Grantor's sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York, without reference to any conflicts of law provisions which would require the application of the laws of any other state or jurisdiction.
