TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT dated as of September 25, 2020 (this "Trademark Agreement"), among Marlins Teamco LLC, a Delaware limited liability company (the "Grantor"), and JPMorgan Chase Bank, N.A. ("JPMCB"), as Administrative Agent.

Reference is made to (a) the Credit Agreement dated as of October 2, 2017 (as amended pursuant to the First Amendment to the Credit Agreement, dated as of March 27, 2019, as further amended pursuant to the Amendment and Incremental Facility Agreement, dated as of the date hereof, and as further amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Marlins Holdings LLC, a Delaware limited liability company ("Holdings"), Marlins Funding LLC, a Delaware limited liability company (the "Borrower"), the Lenders and L/C Issuers from time to time party thereto and JPMCB, as Administrative Agent, and (b) the Security Agreement dated as of October 2, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among Holdings, the Borrower, the Subsidiary Grantors from time to time party thereto and JPMCB, as Administrative Agent. The Lenders and the L/C Issuers have agreed to extend credit to the Borrower subject to the terms and conditions set forth in the Credit Agreement. The obligations of the Lenders and the L/C Issuers to extend such credit are conditioned upon, among other things, the execution and delivery of this Trademark Agreement. The Grantor is an Affiliate of the Borrower, will derive substantial benefits from the extension of credit to the Borrower pursuant to the Credit Agreement and is willing to execute and deliver this Trademark Agreement in order to induce the Lenders and the L/C Issuers to extend such credit. Accordingly, the parties hereto agree as follows:

SECTION 1. Definitions and Rules of Construction.

(a) Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Credit Agreement or the Security Agreement, as applicable.

(b) The rules of construction specified in Article I of the Credit Agreement shall also apply to this Trademark Agreement, *mutatis mutandis*.

(c) As used in this Trademark Agreement, the following terms have the meanings specified below:

"Associated Goodwill" means all goodwill of the Grantor and the Grantor's business, products and services appurtenant to, associated with or symbolized by any Trademarks and the use thereof.

"Pledged Trademarks" means all of the Grantor's right, title and interest in and to all of the Trademarks, Trademark Registrations, Trademark License Rights, Trademark Rights, Associated Goodwill, Related Assets and all accessions to, substitutions for, replacements of, and all products and proceeds of any and all of the foregoing; provided that Pledged Trademarks shall not include any "intent to use" trademark application for which a statement of use has not been filed with the PTO or any other Excluded Assets.

“PTO” means the United States Patent and Trademark Office.

“Related Assets” means all assets, rights and interests of the Grantor that uniquely reflect or embody any Associated Goodwill.

“Trademark License Rights” means any and all past, present or future rights and interests of the Grantor pursuant to any and all past, present and future franchising or licensing agreements in favor of the Grantor, or to which the Grantor is a party, pertaining to any Trademarks, Trademark Registrations or Trademark Rights owned or used by third parties in the past, present or future, including the right (but not the obligation) in the name of the Grantor or the Administrative Agent to enforce, and sue and recover for, any breach or violation of any such agreement to which the Grantor is a party.

“Trademark Registrations” means all present or future federal, state, local and foreign registrations of any Trademarks, all present and future applications for any such registrations (and any such registrations thereof upon approval of such applications), together with the right (but not the obligation) to apply for such registrations (and prosecute such applications) in the name of the Grantor or the Administrative Agent, and to take any and all actions necessary or appropriate to maintain such registrations in effect and renew and extend such registrations.

“Trademark Rights” means any and all past, present or future rights in, to and associated with any Trademarks throughout the world, whether arising under federal law, state law, common law, foreign law or otherwise, including the following: all such rights arising out of or associated with any Trademark Registrations; the right (but not the obligation) to register claims under any state, federal or foreign trademark law or regulation; the right (but not the obligation) to sue or bring opposition or cancellation proceedings in the name of the Grantor or the Administrative Agent for any and all past, present and future infringements or dilution of or any other damages or injury to the Trademarks, the Trademark Rights, or the Associated Goodwill, and the rights to damages or profits due or accrued arising out of or in connection with any such past, present or future infringement, dilution, damage or injury; and the Trademark License Rights.

“Trademarks” means all of the following now or owned or hereafter acquired by the Grantor: all trademarks, service marks, designs, logos, indicia, trade names, corporate names, company names, business names, fictitious business names, trade styles, elements of package or trade dress, and other source and product or service identifiers, used or associated with or appurtenant to the products, services and businesses of the Grantor, including any of the foregoing set forth under its name on Schedule I hereto.

SECTION 2. Grant of Security Interest. As security for the payment or performance in full of all of its Obligations, the Grantor pursuant to the Security Agreement did, and hereby does, grant to the Administrative Agent, for the ratable benefit of each of the Secured Parties, a security interest in and so pledges to the Administrative Agent all of the Grantor’s right, title and interest in, to and under any and all of the Pledged Trademarks, now owned or at any time hereafter acquired by the Grantor(collectively, the “Trademark Collateral”).

SECTION 3. Security Agreement. The security interests granted to the Administrative Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Administrative Agent pursuant to the Security Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Trademark Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 4. Amendment to Schedule. The Grantor authorizes the Administrative Agent to modify this Trademark Agreement without the necessity of the Grantor's further approval or signature, by amending Schedule I hereto to include any future or other Trademarks, Trademark Registrations or Trademark Rights (other than Excluded Assets) identified by the Borrower in any supplement to such schedule delivered pursuant to Section 6.02(g) of the Credit Agreement.

SECTION 5. Major League Baseball Requirements. It is understood and acknowledged that the Grantor's rights and obligations with respect to its Trademarks, Trademark Registrations, Trademark Rights and Trademark Licenses are subject to the MLB Rules and Regulations, and that the Grantor's obligations and the Administrative Agent's rights hereunder are subject to the terms of the MLB Rules and Regulations. Notwithstanding anything herein to the contrary, (i) the parties hereto hereby acknowledge and agree that (a) this Trademark Agreement is subject to the terms of Sections 8.04 and 10.20 of the Credit Agreement, the terms of which are incorporated by reference herein, as if set forth in their entirety herein, and (b) the MLB shall be entitled to enforce the provisions of this Section 5 directly against any party hereto (or their successors and permitted assigns), (ii) neither the Administrative Agent nor any other Secured Party may foreclose upon any Collateral related to the Franchise (including the Trademark Collateral) unless it is also foreclosing on, or has foreclosed on, the Franchise and (iii) neither the Administrative Agent nor any other Secured Party may sell, transfer or otherwise dispose of any Collateral related to the Franchise (including the Trademark Collateral) to any Person, other than any Person that owns or is acquiring the Franchise.

SECTION 6. GOVERNING LAW. THIS TRADEMARK AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK (WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF LAWS OF ANOTHER JURISDICTION).

SECTION 7. Counterparts. This Trademark Agreement may be executed in any number of counterparts and by the different parties hereto on separate counterparts, each of which shall be an original, but all of which together shall constitute one instrument. Delivery of an executed counterpart of a signature page of this Trademark Agreement by facsimile or other electronic imaging shall be effective as delivery of a manually executed counterpart of this Trademark Agreement.


