TRADEMARK ASSIGNMENT

WHEREAS, Ms. Jacqueline Jaeger (“Assignor”), an individual of the United States, with an address at 95 Scenic Drive, Hastings-on-Hudson, New York 10706 owns all trademark rights in **Stick up to Cancer** (“Mark”) and U.S. Trademark Application Serial No. 88/633,617 (“Application”). NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all of Assignor’s right, title, and interest in and to the Trademark Property, including but not limited to the goodwill therein, and the right to sue and collect damages against third parties for all instances of past and future trademark infringement, unfair competition, trademark dilution, and other violations of the laws of any country, with respect to the Trademark Property. After the Effective Date, Assignor shall have no remaining rights whatsoever in the Trademark Property. Assignor agrees to take any further actions requested by Assignee, including but not limited to signing country-specific trademark assignment, to further document this assignment.
