This TERMINATION AND RELEASE OF NOTE PURCHASE AGREEMENT INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of September 25, 2020 (this “**Termination and Release**”), from Blackstone Holdings Finance Co. L.L.C., in its capacity as notes agent for the Purchasers and collateral agent for the Secured Parties under the Security Agreements referred to below (the “**Notes Agent**”), to Audio Visual Services LLC (f/k/a Audio Visual Services Corporation), Audio Visual Services Group, LLC (f/k/a Audio Visual Services Group, Inc. and successor by merger to Visual Aids Electronics Corp., a New York corporation, and Visual Aids Electronics Corp., a District of Columbia corporation), MVP International Inc., PSAV (NY) LLC (as successor by merger to Audio Visual Services (NY) Corporation, a New York corporation) and Encore Event Technologies, LLC (collectively, the “**Grantors**”). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Pledge and Security Agreement referred to below.

A. Reference is made to (i) the Note Purchase Agreement Pledge and Security Agreement dated as of August 24, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “**Pledge and Security Agreement**”), among the Grantors, the Notes Agent and certain other parties thereto, and (ii) the Note Purchase Agreement Intellectual Property Security Agreement dated as of August 24, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “**Intellectual Property Security Agreement**”), made by the Grantors in favor of the Notes Agent (together with the Pledge and Security Agreement, the “**Security Agreements**”).

B. Pursuant to the Pledge and Security Agreement, each Grantor executed the Intellectual Property Security Agreement, and, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations (as defined in the Note Purchase Agreement), granted the Notes Agent a lien on and security interest in all of its right, title and interest in, to and under its Trademarks and Trademark applications listed on Schedule I hereto, recorded with the U.S. Patent and Trademark Office on August 25, 2020 at Reel/Frame 7033/0053, in each case solely to the extent the same constitute Collateral (collectively, the “**Intellectual Property**”).

C. In connection with the repayment in full of all principal, interest, fees and other amounts outstanding under the Note Purchase Agreement, and the release of security interests under the Note Documents, each Grantor has informed the Notes Agent of its desire to obtain the release of all right, title and interest of the Notes Agent, for the benefit of the Secured Parties, in, to and under the Intellectual Property granted under the Intellectual Property Security Agreement.

Accordingly, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Notes Agent does hereby terminate, release, cancel, relinquish and discharge any and all liens and security interests it has in, to and under in the Intellectual Property, and reassigns, retransfers and reconveys all right, title and interest it has in, to and under the Intellectual Property to the applicable Grantor. At the request and sole expense of the Grantors, the Notes Agent shall execute and deliver to the Grantors such further documents as the Grantors shall reasonably request to evidence the release of the Notes Agent’s lien on and security interest in, to and under the

Intellectual Property. This Termination and Release and any further documents, and the performance of any actions by the Notes Agent hereunder or thereunder, are made without representation or warranty by, or recourse to, the Notes Agent or any other Secured Party.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY OR DISPUTE ARISING UNDER OR RELATED TO THIS TERMINATION AND RELEASE, WHETHER IN TORT, CONTRACT (AT LAW OR IN EQUITY) OR OTHERWISE, SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.


