## DECLARATION OF DAVID SCHATZ

The statements in this Declaration are correct, of my own personal knowledge, and I am competent to testify concerning them. Pursuant to 28 U.S.C. § 1746, I, David Schatz, state the following:

1. I am employed by ESCO Technologies Inc. ("ESCO") as the Vice President, Intellectual Property Counsel, and Assistant Secretary. My business address is 9900 A Clayton Rd, St. Louis, Missouri. I have been employed by ESCO for 22 years.

2. I have first-hand knowledge of the corporate structure of ESCO and am privy to all transactions and files related to the corporate structure of ESCO and its related entities, including but not limited to, the intellectual property assets such as trademarks, patents, copyrights, and domain names owned by each ESCO entity.

3. The erroneous filing and recordation of certain security interest and release of security interest agreements against U.S. Registration No. 3,027,379 are evidenced in the U.S. Patent and Trademark Office ("USPTO") trademark record, based on my knowledge of the following:


- a. ESCO Technologies Inc. acquired Xtensible Solutions, Inc. on or around September 7, 2010.
- b. At this time, I was employed by ESCO as Chief Intellectual Property Officer ("CIPO") & Senior Counsel for ESCO Technologies Inc.
- c. ESCO's acquisition of Xtensible Solutions, Inc. included XTENSIBLE SOLUTIONS (Stylized/Design), U.S. Registration No. 3,027,379 as an intellectual property asset.
- d. ESCO converted Xtensible Solutions, Inc. to Xtensible Solutions, LLC on or

around October 1, 2010. This conversion is evidenced by way of the Delaware Secretary of State Certificate of Conversion from Xtensible Solutions, Inc. to Xtensible Solutions, LLC, effective October 1, 2010, and recorded by the USPTO Assignment Recordation Branch on July 27, 2011, at Reel/Frame 4570/0412.

- e. ESCO also owned a company called Aclara Technologies LLC.
  - f. ESCO sold Aclara Technologies LLC on or around March 28, 2014.
  - g. Aclara Technologies LLC, or others acting on their behalf, erroneously filed a security interest against the subject mark on or around August 30, 2016, some two years after they were no longer affiliated with ESCO or Xtensible. This security interest has been recorded by the USPTO Assignment Recordation Branch on August 30, 2016, at Reel/Frame 5866/0857.
  - h. Aclara Technologies LLC, or others acting on their behalf erroneously filed a release of security interest against the subject mark on or around February 2, 2018, some four years after they were no longer affiliated with ESCO or Xtensible. This release of security interest has been recorded by the USPTO Assignment Recordation Branch on February 2, 2018, at Reel/Frame 6264/0911.
4. Based on the above-mentioned facts, it is my understanding and belief that the recordings at Reel/Frame 5866/0857 and Reel/Frame 6264/0911 should not be associated with U.S. Registration No. 3,027,379.
5. The information contained in this Declaration is based on my first-hand knowledge of ESCO and Xtensible's business operations, my review of all reasonably accessible information related to the entities.



I declare under penalty of perjury that the foregoing is true and correct.

## TRADEMARK SECURITY AGREEMENT

This Trademark Security Agreement, dated as of August 29, 2016, by ACLARA TECHNOLOGIES LLC, ACLARA METERS LLC and SMART GRID SOLUTIONS LLC (individually, a “Pledgor”, and, collectively, the “Pledgors”), in favor of MORGAN STANLEY SENIOR FUNDING, INC., in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the “Collateral Agent”).

WITNESSETH:

WHEREAS, the Pledgors are party to a Guarantee and Collateral Agreement of even date herewith (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”) in favor of the Collateral Agent pursuant to which the Pledgors are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Collateral Agent, for the benefit of the Secured Parties, to enter into the Credit Agreement, the Pledgors hereby agree with the Collateral Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Collateral Agreement and used herein have the meaning given to them in the Collateral Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. Each Pledgor hereby pledges and grants to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all the following Pledged Collateral of such Pledgor (collectively, “Trademark Collateral”):

(a) Trademarks of such Pledgor, including those listed on Schedule I attached hereto, excluding in each case any “intent-to-use” applications filed with the United States Patent and Trademark Office prior to the filing and acceptance of a statement of use or an amendment to allege use in connection therewith.;

(b) all Goodwill associated with such Trademarks; and

(c) all proceeds of any and all of the foregoing (other than Excluded Property).

SECTION 3. Collateral Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Collateral Agreement and Pledgors hereby acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Collateral

Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Collateral Agreement, the provisions of the Collateral Agreement shall control unless the Collateral Agent shall otherwise determine.

SECTION 4. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Trademark Security Agreement by signing and delivering one or more counterparts.


