TRADEMARK SECURITY AGREEMENT RELEASE

This TRADEMARK SECURITY AGREEMENT RELEASE (this “**Release**”), dated September 25, 2020, is made by and between NM Nevada Trust, a Massachusetts trust (the “**Grantor**”), and Deutsche Bank AG New York Branch in its capacity as collateral agent and administrative agent (in such capacity, the “**Collateral Agent**”). All capitalized terms used herein and not otherwise defined shall have the meaning assigned to such terms in the Trademark Security Agreements or the Security Agreements (as defined below).

WHEREAS, the Grantor is party to that certain ABL Guarantee and Collateral Agreement, dated as of October 25, 2013, in favor of the Collateral Agent, and that certain Amended and Restated ABL Guarantee and Collateral Agreement, dated as of June 7, 2019, in favor of the Collateral Agent (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “**Security Agreements**”);

WHEREAS, under the terms of the Security Agreements, the Grantor granted to the Collateral Agent a security interest in and to certain trademarks of the Grantor and executed and delivered (i) the Trademark Security Agreement, dated as of September 12, 2019, in favor of the Collateral Agent, as recorded with the United States Patent and Trademark Office (“USPTO”) on September 12, 2019 at Reel 6745, Frame 0503, (ii) the Trademark Security Agreement, dated as of October 25, 2013, in favor of the Collateral Agent, as recorded with the USPTO on November 8, 2013 at Reel 5150, Frame 0619, (iii) the Trademark Security Agreement, dated as of October 17, 2017, in favor of the Collateral Agent, as recorded with the USPTO on October 17, 2017 at Reel 6184, Frame 0398, and (iv) the Trademark Security Agreement, dated as of November 14, 2017, in favor of the Collateral Agent, as recorded with the USPTO on November 15, 2017 at Reel 6206, Frame 0414 (each, as amended, amended and restated, supplemented or otherwise modified from time to time, a “**Trademark Security Agreement**”, and collectively the “**Trademark Security Agreements**”); and

WHEREAS, the Collateral Agent wishes to release its security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreements), including the Trademark Collateral listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Security Interest. The Collateral Agent hereby terminates the Trademark Security Agreements and releases, discharges and relinquishes all right, title and interest in and to the Trademark Collateral, including the Trademark Collateral listed on Schedule I hereto, and all goodwill associated therewith. If and to the extent the Collateral Agent has acquired any right, title or interest in and to the Trademark Collateral, the Collateral Agent hereby re-transfers, re-conveys, and re-assigns such right, title or interest to the Grantor.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office and any other applicable government officer record this Release.

SECTION 3. Further Assurances. The Collateral Agent agrees to take all further actions and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, in each case as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

SECTION 4. GOVERNING LAW. THIS RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK (EXCEPT FOR CONFLICTS OF LAW PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION).



