**ASSIGNMENT OF INTELLECTUAL PROPERTY  
SECURITY AGREEMENT**

This **ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Assignment**”), dated as of September 25, 2020, is by **CIBC BANK USA** (“**CIBC**” and acting in its capacity as the current and assigning lender in such capacity, the “**Retiring Lender**”) and **FURNITURE ASSET PARTNERS LLC** (individually, “**Furniture**”), acting in its capacity as the successor lender (in such capacity, the “**Successor Lender**”).

**RECITALS:**

**WHEREAS**, TRP Acquisition Inc., an Illinois corporation (the “**Borrower**”), and Retiring Lender are parties to those certain intellectual property security agreements identified in Exhibit A attached hereto (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, collectively, the “**Agreement**”);

**WHEREAS**, pursuant to the Agreements, the Borrower granted to Retiring Lender a lien on the intellectual property described and set forth on Exhibit B attached hereto; and

**WHEREAS**, pursuant to that certain Non-Recourse Loan Sale Agreement by and among Borrower, CIBC, as the Retiring Lender, and Furniture, as Successor Lender, Retiring Lender has assigned to Successor Lender all of its rights, remedies, duties and other obligations under, among other documents, the Agreement, in each instance, in its capacity as the secured lender.

**NOW, THEREFORE**, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Retiring Lender hereby assigns and transfers to Successor Lender and its successors and assigns, all of its rights, title and interest in and to the Agreement.

This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.


