**THIS AGREEMENT** is made the 9<sup>th</sup> day of April 2020

**BETWEEN:**

- (1) **RGN-US IP, LLC** of 15305 Dallas Parkway, Suite 400, Addison, Texas, 75001, United States of America (the "Assignor"); and
- (2) **PATHWAY IP II GmbH** (company registration number CHE-269.357.217) of Dammstrasse 19, 6300, Zug, Switzerland (the "Assignee").

**WHEREAS:**

- (A) The Assignor is the owner of the legal title of the Trade Marks, particulars of which are set out in Schedule 1 ("the Trade Marks").
- (B) Pursuant to the unit purchase agreement between IWG Group Holdings Sarl and RGN-Holdings LLC the legal right, title and interest in and to the units were transferred to IWG Group Holdings Sarl. The Assignee is a subsidiary of IWG Group Holdings Sarl.
- (C) The Assignee has directed that the Assignor assign to the Assignee all its legal right, title and interest in and to the Trade Marks, but no other rights.

**NOW IT IS HEREBY AGREED** as follows:

**1 ASSIGNMENT**

In consideration for the sum of [REDACTED] now paid by the Assignee to the Assignor, the receipt of which is hereby acknowledged, the Assignor hereby assigns unto the Assignee all its legal right, title and interest in and to the Trade Marks including any goodwill attached thereto and together with all common law rights of the Assignor, including but not limited to the rights of action, actual or contingent, in respect of any past, existing or future infringements of the Trade Marks.

**2 FURTHER ASSURANCE**

- 2.1 The Assignor hereby undertakes at its own cost to do all such acts and execute all such documents as may be necessary or desirable to effect the transfer to the Assignee of its legal right, title and interest in and to the Trade Marks.



**3 GOVERNING LAW**

- 3.1 This Agreement shall be governed by and construed in accordance with English law and any matter, claim or dispute arising out of or in connection with this Agreement shall be governed by and construed in accordance with English law.
- 3.2 The parties hereby submit to the exclusive jurisdiction of the English Courts in relation to all matters, claims or disputes arising out of or in connection with this Assignment.
