RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of this 25th day of September, 2020, by NXT CAPITAL, LLC, in its capacity as Agent ("Agent"), in favor of BRIGHTPET NUTRITION GROUP, LLC, a Delaware limited liability company ("Company"). NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby (i) terminates the TSA and (ii) terminates, releases and discharges all liens and security interests in, and reassigns to Grantor all right, title and interest to the following collateral referred to in the TSA (collectively, "Trademark Collateral"):


