**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 30, 2020 (“Release”), is made by Bank of America, N.A., as Collateral Agent (“Collateral Agent”) in favor of Baltimore Orioles Limited Partnership, a Maryland limited partnership (“Grantor”).

WHEREAS, pursuant to that certain Amended and Restated Security Agreement dated as of February 26, 2010 (as amended, restated, modified, supplemented and/or extended from time to time, the “Security Agreement”) by and among the Grantor, Collateral Agent, and others party thereto, and the Amended and Restated Trademark Security Agreement dated as of February 26, 2010 (“Trademark Security Agreement”) by and among the Grantor and Collateral Agent, Grantor granted to the Collateral Agent, for the benefit of the holders of the Secured Obligations (“Secured Parties”), a continuing security interest in and first priority lien on the Pledged Trademarks; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on March 10, 2010 at Reel 4164 Frame 0439.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in and first priority lien on the Pledged Trademarks, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
