**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN  
TRADEMARK RIGHTS**

Dated as of October 1, 2020

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARK RIGHTS (this “Release”) is made as of October 1, 2020 (“Effective Date”) by and between Innerworkings, Inc. (the “Grantor”), in favor of BANK OF AMERICA, N.A., a national banking association, as administrative agent for certain secured parties (in such capacity, the “Agent”).

The lien and security interest evidenced by that certain Trademark Security Agreement (“Security Agreement”), dated as of August 2, 2010, made by and between Grantor and Agent, which was duly recorded on August 13, 2010, at Reel 4260, Frame 0455, on December 6, 2013, at Reel 5168, Frame 0749 and on December 10, 2018, at Reel 6548, Frame 0411 in the United States Patent and Trademark Office, and any other right, title or interest granted to the Agent in the trademarks set forth on Schedule 1 attached hereto is hereby terminated, cancelled, discharged and released, without representation or warranty, and the Agent hereby re-assigns, grants and conveys to the Grantor any right, title or interest it may have in the Trademark Collateral (as defined in the Security Agreement), including any of the trademarks set forth on Schedule 1.


The Agent agrees to take all further actions, and provide to the Grantor and their respective successors, assigns or other legal representatives, all such cooperation and assistance reasonably requested by the Grantor, at the applicable Grantor’s sole cost and expense, to more fully and effectively effectuate the purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York, without regarding to conflicts of law or choice of law principles.
