## RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS **RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST** (this “**Release**”) dated as of September 23, 2020, is executed by **SILICON VALLEY BANK**, a California corporation (“**Bank**”), in favor of **PHARMACEUTICAL STRATEGIES GROUP, LLC**, a Texas limited liability company (“**PSG**”), **PSG CONSULTING, LLC**, a Texas limited liability company (“**Consulting**”), **PSG HEALTH SYSTEMS SOLUTIONS, LLC**, a Texas limited liability company (“**HSS**”), **INTELLIGENT COMPLIANCE SOLUTIONS, LLC**, a Texas limited liability company (“**ICS**”), **PHARMACY BENEFIT MANAGEMENT INSTITUTE, LP**, a Texas limited partnership (“**PBMI**”), **PSG SUPPORT SERVICES, LLC**, a Texas limited liability company (“**Support Services**”), **ARTEMETRX, LLC**, a Texas limited liability company (“**Artemetrx**”), **ARTEMETRX SPECIALTY DRUG SOLUTIONS, LLC**, a Texas limited liability company (“**Specialty**”), and **PSGH, LLC**, a Texas limited liability company (“**PSGH**” and, together with **PSG, Consulting, HSS, ICS, PBMI, Support Services, Artemetrx** and **Specialty**, collectively, “**Borrowers**” and, individually, each a “**Borrower**”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Loan Agreement (as defined below).

### RECITALS

A. Pursuant to that certain:

(i) Amended and Restated Loan and Security Agreement dated May 25, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the “**Loan Agreement**”), by and among Bank and Borrowers;

(ii) Amended and Restated Intellectual Property Security Agreement dated May 25, 2018, by and between Bank and PSG and recorded with the United States Patent and Trademark Office (“USPTO”) on July 31, 2018 at reel/frame 6398/0451, PSG granted to Bank a security interest in PSG’s Intellectual Property including, but not limited to, the Intellectual Property set forth on Exhibits A-1 attached hereto;

(iii) Amended and Restated Intellectual Property Security Agreement dated May 25, 2018, by and between Bank and Consulting, Consulting granted to Bank a security interest in Consulting’s Intellectual Property;

(iv) Amended and Restated Intellectual Property Security Agreement dated May 25, 2018, by and between Bank and HSS, HSS granted to Bank a security interest in HSS’s Intellectual Property;

(v) Amended and Restated Intellectual Property Security Agreement dated May 25, 2018, by and between Bank and ICS and recorded at the USPTO on July 31, 2018 at reel/frame 6398/0389, ICS granted to Bank a security interest in ICS’s Intellectual Property including, but not limited to, the Intellectual Property set forth on Exhibits A-2 attached hereto;

(vi) Amended and Restated Intellectual Property Security Agreement dated May 25, 2018, by and between Bank and PBMI, PBMI granted to Bank a security interest in PBMI’s Intellectual Property;

(vii) Amended and Restated Intellectual Property Security Agreement dated May 25, 2018, by and between Bank and Support Services, Support Services granted to Bank a security interest in Support Services’s Intellectual Property;

(viii) Amended and Restated Intellectual Property Security Agreement dated May 25, 2018, by and between Bank and Artemetrx and recorded at the USPTO on July 31, 2018 at Reel/Frame 6418/0774, Artemetrx granted to Bank a security interest in Artemetrx's Intellectual Property including, but not limited to, the Intellectual Property set forth on Exhibits A-3 attached hereto; and

(ix) Intellectual Property Security Agreement dated May 25, 2018, by and between Bank and Specialty, Specialty granted to Bank a security interest in Specialty's Intellectual Property. The documents referenced in items (ii) through (ix), as the same may have been amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, are individually and collectively referred to herein as the "**Security Agreement**".

**B.** Borrowers have requested, and Bank has agreed, to release its security interest in the Intellectual Property.

### **AGREEMENT**

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby agrees as follows:

(i) Bank, without representation or warranty of any kind, hereby releases, discharges, terminates, and cancels all of its security interest in and to the Intellectual Property, including but not limited to the Intellectual Property set forth on Exhibits A-1, A-2 and A-3 attached hereto, arising under the Security Agreement. If and to the extent that Bank has acquired any right, title, or interest in and to the Intellectual Property under the Security Agreement, Bank, without representation or warranty of any kind, hereby re-transfers, re-conveys, and re-assigns such right, title or interest to the applicable Borrower. The Agent authorizes and requests that this Release be recorded at the USPTO.

(ii) Bank, without representation or warranty of any kind, terminates and cancels the Security Agreement.

(iii) Bank represents and warrants that it has the full power and authority to execute this Release.

(iv) Notwithstanding the foregoing, the Release shall apply solely to a release of Bank's security interest in the Intellectual Property, and nothing herein shall be construed to be a release of any other Collateral securing the Obligations.


(v) This Release may be executed by electronic means and Bank recognizes and accepts the use of electronic records by any other party to which Bank delivers this Release.
