NOW, THEREFORE, Assignor does hereby confirm, nunc pro tunc, the assignment to Assignee of all of Assignor's right, title and interest in and to the Marks along with the goodwill of the business symbolized by the Marks, as of and effective June 1, 2013.

Assignor agrees to assist Assignee in every legal way to evidence, record and perfect this Assignment and to apply for and obtain recordation of and from time to time enforce, maintain, and defend the assigned rights. Assignor agrees that it shall take no actions jeopardizing the existence or enforceability of the assignment set forth herein.
