RELEASE OF SECURITY INTEREST IN TRADEMARKS

September 30, 2020

WHEREAS, Five Star Fragrance Company, Inc., a New York corporation ("Debtor"), granted a security interest in and lien upon certain trademarks and related rights to Wells Fargo Bank, National Association, a national banking association, in its capacity as administrative agent (in such capacity, "Secured Party"), as set forth in the Grant of Security Interest in United States Trademarks, dated January 7, 2011, between Debtor and Secured Party (the "Trademark Security Agreement"), as amended by the Amended and Restated Grant of Security Interest in United States Trademarks, dated as of October 11, 2017 (the "Amended and Restated Trademark Security Agreement");

WHEREAS, Five Star Fragrance Company, Inc. is the assignee of the ownership rights in certain trademark registrations identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, from various affiliated entities, including Aladdin Fragrances, Inc., Niche Marketing Group, Inc., and Model Reorg Acquisition, LLC;

WHEREAS, Aladdin Fragrances, Inc., was the original owner of certain trademarks, including RAFFINEE, Registration Number 1,264,630, which were assigned to Five Star Fragrance Company, Inc. and recorded with the United States Patent and Trademark Office on November 7, 2014 at Reel 5396, Frame 0334, and also LUTECE, Registration Number 1,965,064, which were assigned to Five Star Fragrance Company, Inc. and recorded with the United States Patent and Trademark Office on October 27, 2016 at Reel 5912, Frame 0057, as well as the original owner of the SANTA FE trademark and associated design trademarks, Registration Number 1,509,782, Registration Number 1,524,108, and Registration Number 1,537,886, which were all assigned to Five Star Fragrance Company, Inc. and recorded with the United States Patent and Trademark Office on August 11, 2017 at Reel 6128, Frame 0549;

WHEREAS, Niche Marketing Group, Inc. was the original owner of certain trademarks including INNER REALM, Registration Number 2,169,749, REALM, Registration Number 1,867,411, REALM, Registration Number 1,975,469 and REALM, Registration Number 2,099,664, which were assigned to Five Star Fragrance Company, Inc. and recorded with the United States Patent and Trademark Office on October 27, 2016 at Reel 5910, Frame 0185, as well as the original owner of the bottle design trademarks, Registration Numbers 2,061,700 and 2,105,624, which were assigned to Five Star Fragrance Company, Inc. and recorded with the United States Patent and Trademark Office on April 20, 2017 at Reel 6038, Frame 0354; and also the original owner of the bottle design trademark, Registration Number 1,868,809, which was assigned to Five Star Fragrance Company, Inc. and recorded with the United States Patent and Trademark Office on August 11, 2017 at Reel 6128, Frame 0527;

WHEREAS, Model Reorg, Inc. was the original owner of certain trademarks, including DELICIOUS, Registration Number 3,415,546, which were assigned by merger to Model Reorg

Acquisition, LLC and recorded with the United States Patent and Trademark Office on August 11, 2008 at Reel 4828, Frame 0512 and later assigned to Five Star Fragrance Company, Inc. and recorded with the United States Patent and Trademark Office on August 9, 2017 at Reel 6128, Frame 0504;

WHEREAS, an executed copy of the Amended and Restated Trademark Security Agreement was recorded in the United States Patent and Trademark Office on October 20, 2017 at Reel 6186, Frame 0651;

WHEREAS, Debtor has requested that Secured Party release and reassign its interest in the trademarks more fully identified in Schedule B annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. releases and reassigns to Debtor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Trademark Security Agreement in the trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind;

2. agrees that any power of attorney or similar rights granted by Debtor to Secured Party pursuant to or in connection with the Trademark Security Agreement is terminated; and

3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
