RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this “Release”) is made as of September 30, 2020 by Pacific Western Bank, in its capacity as administrative agent (the “Administrative Agent”), pursuant to that certain Security and Pledge Agreement dated as of April 9, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Security and Pledge Agreement”) by and the grantors party thereto and the Administrative Agent. Capitalized terms used herein have the meanings attributed thereto in the Security and Pledge Agreement unless otherwise defined herein.

WHEREAS, pursuant to the terms and conditions of that certain Notice of Grant of Security Interest in Trademarks (the “Notice”) by Frontpoint Security Solutions, LLC (“Frontpoint”) and acknowledged and accepted by the Administrative Agent, which Notice was recorded with the United States Patent and Trademark Office on April 24, 2015 on Reel 5503 Frame 0701, Frontpoint and the Administrative Agent, acknowledged and agreed that Frontpoint granted the Administrative Agent, for the benefit of the secured parties, a continuing security interest in and continuing lien on the Trademarks listed on Schedule 1 hereto; and


WHEREAS, Frontpoint has requested that the Administrative Agent release the entirety of its security interest in and lien on the Trademarks listed on Schedule 1 and the Administrative Agent has agreed to do so.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

1. Release of Security Interest. The Administrative Agent hereby terminates, cancels, discharges and releases its Security Interest in and any lien on the Trademarks listed on Schedule 1, without warranty or recourse.
2. Further Assurances. The Administrative Agent shall take all further actions, and provide to Frontpoint and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Frontpoint to more fully and effectively effectuate the purposes of this Release, in each case at Frontpoint’s sole expense.
3. Governing Law. This Release shall be construed in accordance with and governed by the law of the State of New York.
