RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of October 7, 2020 by GLAS TRUST COMPANY LLC, as collateral agent (together with its successors in such capacity and as successor to JPMorgan Chase Bank, N.A., the “**Collateral Agent**”), in favor of GNC CORPORATION, GENERAL NUTRITION CENTERS, INC., GENERAL NUTRITION CORPORATION, GNC TRANSPORTATION, LLC, GNC FUNDING, INC., AND GENERAL NUTRITION INVESTMENT COMPANY (each, a “**Grantor**” and collectively, the “**Grantors**”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement (defined below), or if not defined therein, in the Guarantee and Collateral Agreement (defined below).

WHEREAS, the Grantors have executed and delivered that certain Amended and Restated Guarantee and Collateral Agreement, dated as of February 28, 2018, in favor of the Administrative Agent and the Collateral Agent (as amended, restated, amended and restated, supplemented, replaced or otherwise modified from time to time, the “**Guarantee and Collateral Agreement**”), pursuant to which each Grantor granted to the Collateral Agent a lien on and security interest in all right, title and interest of such Grantor in and to certain Collateral;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, (i) the Grantors have executed that certain Intellectual Property Security Agreement, dated as of March 4, 2011 (the “**2011 Trademark Security Agreement**”); (ii) the Grantors have executed that certain Trademark Security Agreement, dated as of November 26, 2013 (the “**2013 Trademark Security Agreement**”); (iii) the Grantors have executed that certain Trademark Security Agreement, dated as of February 28, 2018, in each case, in favor of the Collateral Agent or its predecessor-in-interest (the “**Trademark Security Agreement**”); (iv) the Grantors have executed that certain Trademark Security Agreement (First Supplemental Filing), dated as of April 28, 2020, in each case, in favor of the Collateral Agent or its predecessor-in-interest (the “**First Supplemental Trademark Security Agreement**”); and (v) the Grantors have executed that certain Trademark Security Agreement (Second Supplemental Filing), dated as of May 2, 2020, in each case, in favor of the Collateral Agent or its predecessor-in-interest (the “**Second Supplemental Trademark Security Agreement**”);

WHEREAS, the 2011 Trademark Security Agreement was recorded in the United States Patent and Trademark Office on March 15, 2011 at Reel/Frame 4496/0412 and was assigned by JPMorgan Chase Bank, N.A to the Collateral Agent pursuant to that certain Assignment of Security Interest in Trademarks, dated as of February 28, 2018, which was recorded in the United States Patent and Trademark Office on June 1, 2020 at Reel/Frame 6950/0111;

WHEREAS, the 2013 Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 3, 2013 at Reel/Frame 5165/0089 and was assigned to the Collateral Agent pursuant to that certain Assignment of Security Interest in Trademarks, dated as of February 28, 2018, which was recorded in the United States Patent and Trademark Office on June 1, 2020 at Reel/Frame 6950/0096;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on March 14, 2018 at Reel/Frame 6291/0959;

WHEREAS, the First Supplemental Trademark Security Agreement was recorded in the United States Patent and Trademark Office on April 29, 2020 at Reel/Frame 6926/0016;

WHEREAS, the Second Supplemental Trademark Security Agreement was recorded in the United States Patent and Trademark Office on June 1, 2020 at Reel/Frame 6950/0158; and

WHEREAS, the Grantors have requested that the Collateral Agent terminate, release and discharge fully its lien on and security interest in all right, title and interest in and to the Intellectual Property Collateral (as defined in the Trademark Security Agreement), including the Trademarks (as defined in the 2011 Trademark Security Agreement) and the Trademark Collateral (as defined in each of the 2013 Trademark Security Agreement, the Trademark Security Agreement, the First Supplemental Trademark Security Agreement and the Second Supplemental Trademark Security Agreement), including in each case each trademark, trademark registration, and trademark application listed on the attached Schedule A hereto, and execute a document suitable for recording in the United States Patent and Trademark Office to evidence the termination and release of its lien and security interest as herein provided.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without representation or warranty of any kind, hereby (a) terminates, releases, relinquishes and discharges, with respect to the Grantors, all of its entire right, title, and interest in and to (including all of its lien on and security interest in and to) all of the Grantors' right, title, and interest in, to and under the Intellectual Property Collateral, including the Trademarks (as defined in the 2011 Trademark Security Agreement) and the Trademark Collateral (as defined in each of the 2013 Trademark Security Agreement, the Trademark Security Agreement, the First Supplemental Trademark Security Agreement and the Second Supplemental Trademark Security Agreement), including in each case each trademark, trademark registration, and trademark application listed on the attached Schedule A hereto; and (b) re-assigns to the Grantors any right, title and interest it may have in, to and under such Intellectual Property Collateral.

The Collateral Agent hereby authorizes the Grantors, or the Grantors' authorized representatives, to record this Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency. The Collateral Agent agrees to, at the request and expense of the Grantors, execute and deliver to the Grantors other instruments and other documents as may be necessary to release the lien on and security interest in the Intellectual Property Collateral, including the Trademarks (as defined in the 2011 Trademark Security Agreement) and the Trademark Collateral (as defined in each of the 2013 Trademark Security Agreement, the Trademark Security Agreement, the First Supplemental Trademark Security Agreement and the Second Supplemental Trademark Security Agreement).


