## AMENDMENT TO COMMERCIAL SECURITY AGREEMENT

This Amendment to Commercial Security Agreement (this "Amendment") is entered into effective as of September 30, 2018 (the "Amendment Date"), by and among Paragon 28, Inc., a Colorado corporation ("Borrower"), and Zions Bancorporation, N.A. dba Vectra Bank Colorado ("Lender").

### RECITALS

- A. Borrower and Lender (as successor-in-interest to ZB, N.A. dba Vectra Bank Colorado pursuant to a merger) entered into that certain Commercial Security Agreement, dated as of June 20, 2018, which replaced that certain Amended and Restated Commercial Security Agreement, dated as of May 18, 2017 (collectively, as the same may be further amended, modified, extended, renewed, restated, or supplemented from time to time, the "Security Agreement").
- B. Lender made filings with the USPTO in order to reflect Lender's name change after the merger; however, such filings inadvertently triggered the USPTO to list in its database that Lender was the owner of certain intellectual property rather than merely reflecting Lender's name change with respect to the security interest filings made with the USPTO.
- C. Lender desires to clear up the record and amend the Security Agreement to reflect the current name of Lender, and to correct the USPTO record. Although the parties are signing this Amendment on September 15, 2020, the parties intend for the agreement to be effective as of the Amendment Date, which was the date of such name change.

### AGREEMENT

NOW, THEREFORE, in consideration of the foregoing recitals and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, and intending to be legally bound, the parties hereto agree as follows:


1. **AMENDMENT TO THE SECURITY AGREEMENT.** The Security Agreement is hereby amended by replacing "ZB, N.A., d/b/a Vectra Bank Colorado ("Lender")" with "Zions Bancorporation, N.A. dba Vectra Bank Colorado ("Lender")". All references in the Security Agreement from and after the Amendment Date to "Lender" in the Security Agreement shall be references to "Lender" as amended by the foregoing.
2. **LIMITATION OF AMENDMENTS; RESERVATION OF RIGHTS.** This Amendment is for purposes of reflecting Lender's name change in the Security Agreement only for purposes of clearing up the record with the USPTO. All other the provisions of the Security Agreement shall remain in full force and effect.
3. **FILING.** This Amendment shall be filed as a corrective filing in the Trademark Assignment Records as a correction to the document filed as Reel: 006552, Frame: 0596, and in the Patent Assignment Records as a correction to the document filed as Reel: 047734, Frame: 0710.


