RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this “Release”) is made as of October 1, 2020 (“Effective Date”) by Deerpath Funding, LP, a Delaware limited partnership, as administrative agent and collateral agent for the Lenders (“Grantee”) under the IP Security Agreements (as defined below), in favor of Insurance Technologies, LLC, a Delaware limited liability company, with its principal office at 2 South Cascade Avenue, Suite 200, Colorado Springs, CO 80903 (“Grantor”). Capitalized terms used herein without definition are used as defined in the IP Security Agreements.

WHEREAS, pursuant to the terms and conditions of that certain (i) Patent and Trademark Security Agreement by and between Grantor and Grantee dated December 1, 2014 (the “First IP Security Agreement”) and (ii) Patent and Trademark Security Agreement by and between Grantor and Grantee dated August 17, 2018 (the “Second IP Security Agreement” and, together with the First Security Agreement, the “IP Security Agreements”), Grantor granted to Grantee a continuing security interest in and to the IP Collateral, including, without limitation, the United States trademark registrations and applications set forth on Schedule A attached hereto;

WHEREAS, Grantor and Grantee entered into the IP Security Agreements pursuant to the terms and conditions of that certain Security Agreement by and between, among others, Grantor and Grantee dated December 1, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “Security Agreement”);

WHEREAS, the First IP Security Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on December 1, 2014, at Reel 005410, Frame 0564 and the Second IP Security Agreement was recorded with the USPTO on August 28, 2018, at Reel 006431, Frame 0626;

WHEREAS, Grantor has paid all of its outstanding Obligations to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:


1. **Release**. Grantee hereby irrevocably terminates the IP Security Agreements, and hereby terminates, cancels, extinguishes, discharges and releases, in its entirety, any and all security interests it has against the IP Collateral. Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the IP Collateral and (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name, other than those items of IP Collateral set forth on Schedules A (attached hereto), in any jurisdiction throughout the world.
2. **Recordation**. The parties hereto authorize and request that the Commissioner for Patents and Trademarks at the USPTO or its delegate record this Release against the IP Collateral.
3. **Further Assurances**. Grantee shall, at Grantor’s expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.
4. **Counterparts**. This Release may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together one and the same agreement.
