TRADEMARK ASSIGNMENT

This trademark assignment (this "Assignment") is made and entered effective *nunc pro tunc* April 27, 2020 (the "Effective Date") by and between Rhino Trading, LLC, a Nevada limited liability company with an address of 101 Dominion Blvd., Ronkonkoma New York 11779 ("Rhino"), and Ryan Bucki, an individual with an address of 5100 Wayzata Blvd. #422E, Golden Valley, Minnesota 55416 ("Bucki"), hereinafter individually referred to as "Party" and collectively as "Parties."

Whereas, As of the Effective Date, Rhino and Bucki have been jointly involved in the development and marketing of certain products to be offered under the FIT SPICES and FIT SPICE marks;

Whereas, Each party has separately filed application to register FIT SPICES and FIT SPICE; and

Whereas, In order to accurately reflect their joint interest and ownership of business to which the FIT SPICES and FIT SPICE marks pertain each Party wishes to assign to the other Party an undivided 50% in interest, along with goodwill associated therewith, in the trademarks reflected in U.S. Application Serial No. 88883797 for FIT SPICES (the '793 Mark) and U.S. Application Serial No. 88900341 for FIT SPICE (the '341 Mark), (collectively the "Assigned Trademarks").

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignment of 50% interest in '797 Mark. Bucki hereby assigns, transfers, and sets over to Rhino an undivided 50% interest right, title, and interest in and to the '797 Mark, together with the goodwill of the business symbolized in the '797 Mark along with the portion of Bucki's business to which the mark pertains, and all other corresponding rights that are or may be secured under the laws of the United States and any foreign country, now or hereafter in effect, for Rhino's own use and enjoyment, and for the use and enjoyment of Rhino's successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Rhino if Rhino was listed as a co-owner as of the filing of the application to register the '797 Mark.

Assignment of 50% interest in '341 Mark. Rhino hereby assigns, transfers, and sets over to Bucki an undivided 50% interest right, title, and interest in and to the '341 Mark, together with the goodwill of the business symbolized in the '341 Mark along with the portion of Rhino's business to which the mark pertains, and all other corresponding rights that are or may be secured under the laws of the United States and any foreign country, now or hereafter in effect, for Bucki's own use and enjoyment, and

for the use and enjoyment of Bucki's successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Bucki if Bucki was listed as a co-owner as of the filing of the application to register the '341 Mark.

The Parties hereby authorizes and requests the Commissioner for Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Rhino and Bucki as equal joint owners of the Assigned Trademarks.
