SECOND: The date the original Articles of Incorporation of the Corporation was first filed with the Secretary of State of the State of Georgia was October 17, 1996.

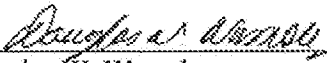
THIRD: The original name of the Corporation as set forth in its original Articles of Incorporation is WebMD, Inc.

The undersigned, being duly authorized to execute this Certificate of Formation, hereby certifies that:

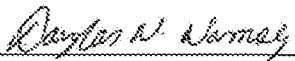
FIRST: The name of the Limited Liability Company is WebMD LLC.
