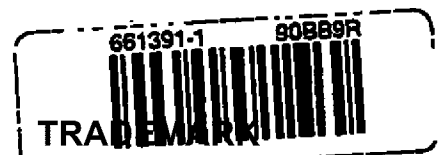

This **PLAN OF CONVERSION** (this "Plan"), dated as of September 30, 2017, is hereby adopted by **MORTARA INSTRUMENT, INC.**, a Wisconsin corporation (the "Corporation"), in accordance with Section 180.1161 of the Wisconsin Business Corporation Law.

RECITALS

A. The Corporation is a corporation incorporated and existing under Chapter 180 of the Wisconsin Statutes.

B. The Corporation's authorized capital stock consists of 150,000 shares of Class A Voting Common Stock and 1,350,000 shares of Class B Nonvoting Common Stock. There are currently 62,620 shares of Class A Voting Common Stock and 1,017,715.50 shares of Class B Nonvoting Common Stock issued and outstanding (the "Common Stock").

C. The sole shareholder and directors of the Corporation deem it advisable for the benefit of the Corporation and its sole shareholder that the Corporation be converted into a Wisconsin limited liability company under and pursuant to the Wisconsin Business Corporation Law ("WBCL").

D. The sole shareholder and the directors of the Corporation have approved the conversion of the Corporation into a Wisconsin limited liability company under the terms and conditions set forth below.

PLAN OF CONVERSION

In consideration of the Recitals, the Corporation hereby adopts the following Plan of Conversion:

**ARTICLE I
THE CONVERSION**

At the Effective Date (as defined below), upon the terms and subject to the conditions of this Plan, and in accordance with the WBCL, Mortara Instrument, Inc., a Wisconsin corporation, shall be converted into a limited liability company organized and existing under Chapter 183 of the Wisconsin Statutes and shall be named Mortara Instrument, LLC (the "Conversion"). Following the Conversion, the Corporation shall cease to exist as a Wisconsin corporation and shall instead exist as a Wisconsin limited liability company.

ARTICLE II
EFFECTIVE DATE

Subject to the terms and conditions set forth in this Plan, a Certificate of Conversion shall be duly executed and acknowledged by the Corporation and thereafter delivered to the Department of Financial Institutions of the State of Wisconsin for filing pursuant to the WBCL. The Conversion shall become effective as of September 30, 2017 (the "Effective Date").

ARTICLE III
EFFECTS OF THE CONVERSION

The Conversion shall have the effects set forth in the WBCL. Without limiting the generality of the foregoing, at the Effective Date, all the properties, rights, privileges, powers and franchises of the Corporation shall vest in Mortara Instrument, LLC and all debts, liabilities and duties of the Corporation shall become the debts, liabilities and duties of Mortara Instrument, LLC.

ARTICLE IV
ARTICLES OF ORGANIZATION

The Articles of Organization of Mortara Instrument, LLC, which shall take effect on the Effective Date, are attached hereto as Exhibit A.

ARTICLE V
CONVERSION OF SHARES

At the Effective Date, the outstanding shares of Class A and Class B Common Stock of the Corporation which are issued and outstanding immediately prior to the Effective Date shall, by virtue of the Conversion and without any action on the part of the Corporation or the holder of the shares of Common Stock, be collectively converted into and shall thereafter collectively represent a 100% limited liability company membership interest in Mortara Instrument, LLC. The outstanding certificates representing shares of Common Stock shall thereafter be void and of no further force or effect.
