TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment is entered into as of October 13, 2020, by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, a national banking association, in its capacity as Secured Party for itself, as Lender, and the Bank Product Providers (the "Secured Party").

Chargeurs Protective, Inc., a Delaware corporation ("Chargeurs"), and Troy Laminating and Coating, Inc., a Delaware corporation ("Troy"), and together with Chargeurs, "Grantors" and each a "Grantor"), entered into a Trademark Security Agreement among the Grantors and the Secured Party, dated as of October 6, 2017, pursuant to which the Grantors granted the Secured Party a security interest in the Trademark Collateral as defined therein, including the Trademarks and Trademark Intellectual Property Licenses referred to on Schedule I hereto (the "Trademark Agreement").

The Trademark Agreement was recorded by the Assignment Recordation Branch of the United States Patent and Trademark Office on October 19, 2017, at Reel 6186, Frame 0197.

The Grantors have requested that the Secured Party release its security interest in the Trademarks.

ACCORDINGLY, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


1. As used herein, capitalized terms defined in the Trademark Agreement and not otherwise defined herein have the meanings given them in the Trademark Agreement.

2. The Secured Party hereby irrevocably releases its security interest in the Trademark Collateral, including without limitation the Trademarks and Trademark Intellectual Property Licenses referred to on Schedule I hereto.

3. Subject to other security interests, if any, granted by the Grantors to other financial institutions, the Secured Party hereby reassigns, grants and conveys to the Grantors, without any representation, warranty, recourse or undertaking by the Secured Party, all of the Secured Party's right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks and Trademark Intellectual Property Licenses referred to on Schedule I hereto.
