TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of October 9, 2020 (“Effective Date”), by **TC LENDING, LLC**, a Delaware limited liability company (“TCL”), as Collateral Agent for the Secured Parties (in such capacity, the “Collateral Agent”), in favor of **MAVERICK HOLDING, INC.**, a Delaware corporation (“Holdings”), **MEDEANALYTICS, INC.**, a Delaware corporation (“Borrower”), and **ONFOCUS HEALTHCARE, INC.**, a Delaware corporation (collectively, the “Grantors”). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Credit Agreement (defined below) (or if not defined therein, the Security Agreement (defined below)).

WHEREAS, reference is made to: (a) that certain Credit Agreement, dated as of September 30, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among Holdings, Borrower, the Lenders from time to time party thereto, and TCL, as Administrative Agent and as Collateral Agent, and (b) that certain Security Pledge Agreement, dated as of September 30, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the Grantors, the other Grantors (as defined in the Security Agreement) and Collateral Agent;

WHEREAS, pursuant to the terms and conditions of the Security Agreement and that certain Grant of Security Interest in Trademark Rights, dated as of September 30, 2015, by and between the Grantors and Collateral Agent, (as amended, restated, supplemented, or otherwise modified and in effect from time to time, the “Trademark Security Agreement”), which was recorded by the United States Patent and Trademark Office on October 5, 2015, at Reel 005637, Frame 0751, the Grantors granted to Collateral Agent a security interest in all of the Grantors’ right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, Collateral Agent now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on **Schedule 1** hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby covenants and agrees as follows:


1. Without representation or warranty of any kind or nature, Collateral Agent hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Security Agreement and the Trademark Security Agreement, and reassigns to the Grantors all right, title, and interest of Collateral Agent in the Trademark Collateral pursuant to the Security Agreement and the Trademark Security Agreement.

2. Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at the Grantors’ expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
