**TERMINATION AND RELEASE OF GRANT OF INTELLECTUAL PROPERTY  
SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF GRANT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "**Termination**"), is dated as of October [13], 2020, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "**Grantee**"), to **MED AIR, LLC**, a Delaware limited liability company ("**Med Air**"), and **MEDWAY AIR AMBULANCE, LLC**, a Georgia limited liability company ("**Air Ambulance**") and together with Med Air, collectively, the "**Grantors**" and each individually, a "**Grantor**").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of October 15, 2019, by the Grantors in favor of the Grantee (the "**Security Agreement**"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Trademarks (as defined in the Security Agreement) and Copyrights (as defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office ("**USPTO**") on October 16, 2019 at Reel/Frame 6772/0417;

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. **Definitions.** Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

2. **Release of Security Interest.** Grantee hereby terminates the Security Agreement and irrevocably terminates, releases and discharges the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement, in the Trademarks and Copyrights listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark and Copyright, and, without representation, recourse or warranty whatsoever, reassigns, transfers and conveys to Grantor all right, title and interest of Grantee in the Trademarks and Copyrights, including all of the goodwill of the business connected with the use of, and symbolized by, each Trademark and Copyright, and any right, title or interest of the Grantee in such Trademarks and Copyrights shall hereby terminate, cease and become void.


3. **Further Assurances.** Grantee hereby authorizes each Grantor or an authorized representative of such Grantor to (i) record this Termination with the USPTO, (ii) record this Termination with the United States Copyright Office, and/or (iii) otherwise record or file this Termination in the applicable governmental office or agency. Grantee further agrees to execute and deliver to any Grantor any and all further documents and instruments, and do any and all further acts which such Grantor (or its agents or designees) reasonably requests (at such Grantor's

sole cost and expense) in order to confirm this Termination and such Grantor's right, title and interest in, to and under the Trademarks and/or Copyrights.
