**TERMINATION AND RELEASE OF
GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (“Release”) is made as of this 14th day of October, 2020, by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as administrative agent (“Agent”), in favor of ARRAY TECHNOLOGIES, INC., a New Mexico corporation (“Grantor”).

WHEREAS, Grantor entered into that certain Grant of Security Interest in United States Trademarks, dated July 8, 2016, with Agent, notice of which was recorded with the United States Patent and Trademark Office on July 12, 2016 at reel/frame 5833/0608 (the “Trademark Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted to Agent, under the terms of the Trademark Security Agreement, a security interest in favor of Agent, in and to all of their right, title and interest in and to the trademark collateral, including without limitation the Marks listed in Schedule I.

WHEREAS, Agent has agreed to terminate and release its security interest in all such trademark collateral, including without limitation such Marks, as herein provided.


FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby releases, terminates and discharges its security interest in the trademark collateral, including without limitation, the rights, title and interest in, to and under the Marks listed on Schedule I attached hereto and made a part hereof, all Proceeds and products of the Marks, the goodwill of the businesses with which the Marks are associated, and all causes of action for infringement of the Marks or unfair competition regarding the same, and

hereby assigns, transfers and conveys to Grantor any and all interest in all of the foregoing, including the security interest.
