RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

WHEREAS, by a certain Assignment of Trademark Security Agreement (as amended, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Agreement"; terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Agreement) dated as of June 9, 2015, by and among **GENERAL ELECTRIC CAPITAL CORPORATION** (the "Previous Agent"), as assignor, and **WELLS FARGO BANK, NATIONAL ASSOCIATION** (the "Agent"), as assignee, which Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on June 11, 2015, on reel 5550 frame 0816, Previous Agent assigned to Agent, and Agent assumed, all of Previous Agent's right, title, and interest in and to the Existing Trademark Grant, made by **SOUTHWEST STAINLESS, L.P.**, a Delaware limited partnership now known as Sunbelt Supply LP (the "Released Grantor"), in favor of Previous Agent pursuant to that certain Trademark Security Agreement, dated March 26, 2012, and recorded with the USPTO on April 12, 2012 on reel 4755 frame 0561, as amended by Amendment to Trademark Security Agreement, dated November 6, 2012, by and among Previous Agent and Released Grantor and recorded with the USPTO on November 6, 2012, on reel 4895 frame 0041, and pursuant to the Agreement, Agent has a continuing security interest in all of the Released Grantor's Trademark Collateral including the trademarks listed on Schedule I attached hereto; and

WHEREAS, Agent has agreed at the request of the Released Grantor to release its security interest in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby (a) terminates, cancels and releases the Liens and security interests created under the Agreement in the Trademark Collateral, (b) releases its security interest in the Trademark Collateral and re-pledges, reassigns any and all interests it may have in the Trademark Collateral to the Released Grantor, (c) discharges any and all rights, title and interest it has in and the security interest granted to the Agent in the Trademark Collateral and (d) terminates the Agreement.
