This Deed of Assignment is made between:




1. The Assignor absolutely assigns its entire right, title, and interest in and to the Trade Marks to the Assignee. This Assignment also includes the right to sue for damages and other remedies in respect of any infringement of the Trade Marks which may have occurred prior to the date of this Deed.
2. The Assignee accepts the Assignment from the Assignor.
3. The Assignor undertakes, at the expense of the Assignee, to do all acts and execute all

documents necessary or reasonable for further assuring the rights of the Assignee in and to the Trade Marks, and will facilitate the recordal of the Assignee as the registered proprietor of the Trade Marks on the appropriate Register or other official record.

4. The Assignor undertakes, at the expense of the Assignee, to render all reasonable assistance to the Assignee in respect of any action for infringement in relation to the Trade Marks.
5. The assignment is together with the goodwill of the business in which the Trade Marks are used.
6. This Deed may be executed in any number of counterparts and all those counterparts taken together shall constitute one and the same instrument.
7. The Effective Date of this Deed is the date on which the last party executes the Deed.
8. Each of the parties warrants:
 - (i) that the name, details of incorporation (as applicable) and address of the party are correctly stated herein; and
 - (ii) its power to enter into this Deed.
