**TERMINATION AND RELEASE OF GRANT OF A SECURITY
INTEREST - TRADEMARKS**

THIS TERMINATION AND RELEASE OF GRANT OF A SECURITY INTEREST – TRADEMARKS (this “Termination”), is dated as of July 20, 2020, and made by **PNC BANK, NATIONAL ASSOCIATION** (the “Grantee”), to Borden Dairy Company, a Delaware corporation, Borden Dairy Company of Madisonville, LLC, a Kentucky limited liability company, Borden Dairy Company of Ohio, LLC, a Delaware limited liability company, Borden Dairy Company of South Carolina, LLC, a South Carolina limited liability company, Borden Dairy Company of Florida, LLC, a Delaware limited liability company and National Dairy, LLC a Delaware limited liability company (each a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Grant of a Security Interest – Trademarks dated as of July 6, 2017, made by Grantors in favor of Grantee (the “Security Agreement”), a security interest was granted by the Grantors to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on August 1, 2017 at Reel/Frame 6120/0538;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term “Intellectual Property,” as used herein, shall mean all of the Grantors’ right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.
