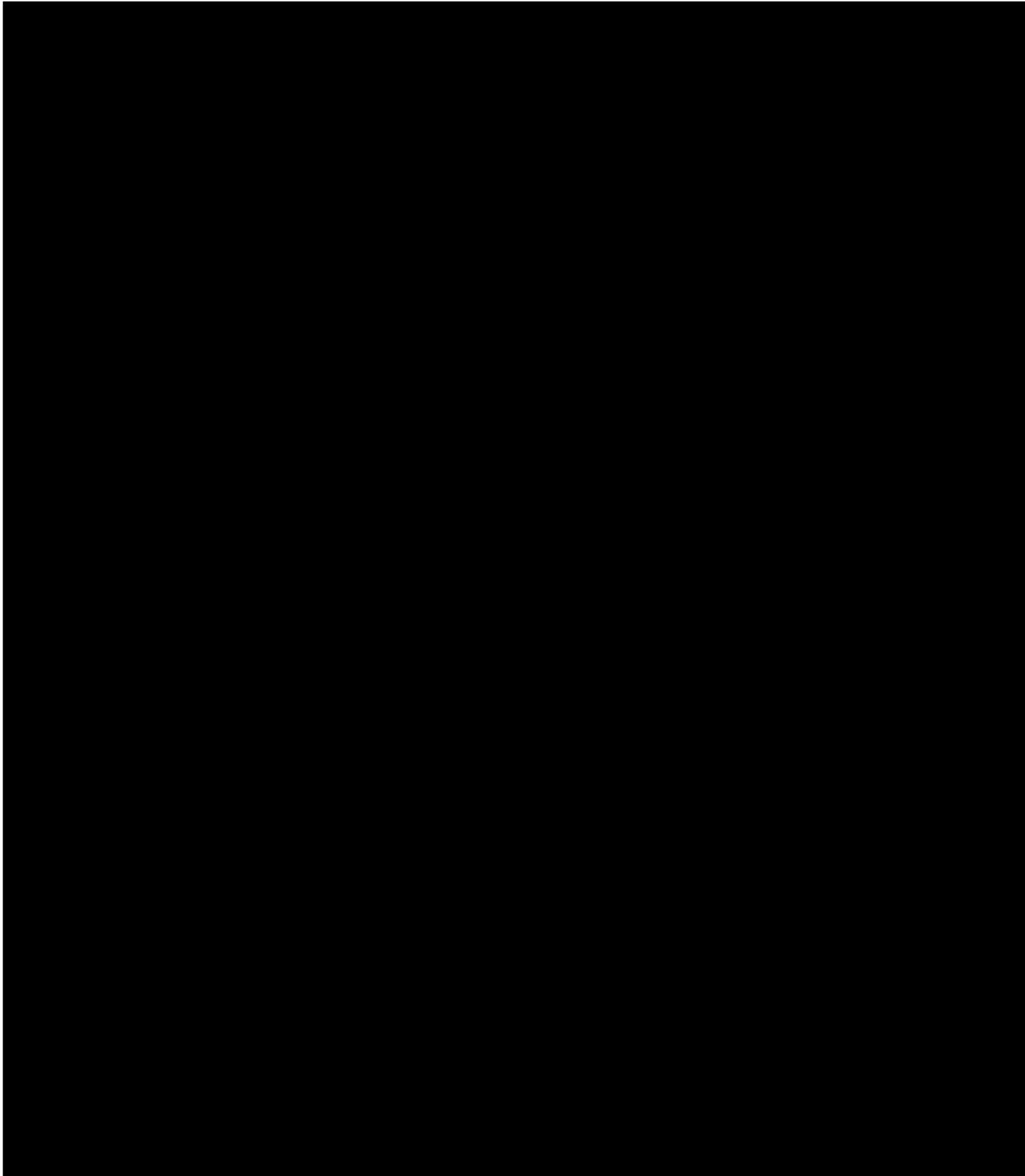




("CAC"), having a principle place of business at 1405 Blackburn, Plano, Texas 75025 is the owner of U.S. Federal Trademark Registration No. 1,544,052 along with certain common law and any other rights in the mark DEFENDER (word) as used in connection with chemical sold in an aerosol dispenser for personal self defense ("DEFENDER Mark");

WHEREAS, ARMAMENT SYSTEMS & PROCEDURES ("ASP"), having a principle place of business at 2511 E. Capital Drive, Appleton, Wisconsin 54911 is the owner of U.S. Federal Registration Nos. 3,219,800 for PALM DEFENDER; 2,969,877 for ASP DEFENDER; 2,725,349 for STREET DEFENDER; 2,599,118 for EXECUTIVE DEFENDER; 2,592,566 for TACTICAL DEFENDER for use in connection with chemical agents used for personal self-defense sold in aerosol dispensers and U.S. Trademark Registration Nos. 2,175,918 for KEY DEFENDER OC and 2,031,360 for KEY DEFENDER ("ASP Marks") for use in connection with personal safety defense products, namely, irritant-projecting dispensers;

WHEREAS, CAC wishes to sell and ASP wishes to acquire the CAC's U.S. Trademark Registration No. 1,544,052 and any associated rights in the DEFENDER Mark, including any state or common law rights;
