**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

**WHEREAS**, by a certain Trademark Security Agreement (as amended, amended and restated, supplemented or otherwise modified prior to the date hereof, the “Agreement”; terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Agreement or in the Guaranty and Security Agreement referred to therein) dated as of March 26, 2012 by **SOUTHWEST STAINLESS, L.P.**, a Delaware limited partnership now known as Sunbelt Supply LP, and **MAIN STEEL POLISHING COMPANY, INC.**, a New Jersey corporation now known as MSP 2014 Company, Inc. (collectively, the “Released Grantors”; individually, each a “Released Grantor”), in favor of **GENERAL ELECTRIC CAPITAL CORPORATION** (the “Prior Agent”), which Agreement was recorded with the United States Patent and Trademark Office (the “USPTO”) on April 12, 2012 on reel 004755 frame 0561, the Released Grantors granted, assigned and pledged to the Prior Agent a security interest in, all of its Trademark Collateral including the trademarks listed on Schedule I attached hereto; and

**WHEREAS**, pursuant to that certain Assignment of Trademark Security Agreement dated as of June 9, 2015, by and among Prior Agent, as assignor, and **WELLS FARGO BANK, NATIONAL ASSOCIATION** (the “Agent”), as assignee, which Assignment of Trademark Security Agreement was recorded with the USPTO on June 11, 2015, on reel 005550 frame 0816, Prior Agent assigned to Agent, and Agent assumed, all of Prior Agent’s right, title, and interest in and to the Released Trademark Collateral under the Agreement; and

**WHEREAS**, Agent has agreed at the request of the Released Grantors to release its security interest in the Trademark Collateral.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby (a) terminates, cancels and releases the Liens and security interests created under the Agreement in the Trademark Collateral, (b) releases its security interest in the Trademark Collateral and re-pledges, reassigns any and all interests it may have in the Trademark Collateral to the applicable Released Grantor, (c) discharges any and all rights, title and interest it has in and the security interest granted to the Agent in the Trademark Collateral, and (d) terminates the Agreement.
