**TERMINATION AND RELEASE OF TRADEMARK  
SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release"), dated this 16th day of October, 2020, is by Freeport Financial Partners LLC, as Agent ("Agent") for the Lenders (as defined in the Credit Agreement referred to below).

A. WHEREAS, pursuant to the Credit Agreement, dated as of November 18, 2019 (as the same may be amended, restated, supplemented and/or modified from time to time, the "Credit Agreement"), by and among Northpoint Recovery Holdings LLC (the "Borrower"), Northpoint Recovery LLC ("Grantor"), the other Loan Parties party thereto, the lenders party thereto (the "Lenders"), and the Agent, as Agent for the Lenders, the Lenders have severally agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

B. WHEREAS, Grantor granted Agent a security interest in its trademarks listed on Schedule A (collectively the "Trademarks") pursuant to a Trademark Security Agreement dated November 18, 2019 (the "Security Agreement");

B. WHEREAS the Agent recorded its interest in the Trademarks with the United States Patent and Trademark Office (the "USPTO") on November 19, 2019, in Reel 6798 Frame 0804; and

C. WHEREAS Grantor requests that the Agent release any and all right, title, and interest in and to the Trademarks, and the Agent agrees to release any and all such right, title, and interest.


NOW, THEREFORE, FOR VALUE RECEIVED, the Agent agrees as follows:

- 1) The Agent does hereby terminate and release the Security Agreement and its security interest in and to the Trademarks and all rights therein of any type or description.
- 2) The Agent hereby authorizes Grantor (or its authorized representative) to file copies of this Release with the USPTO, and any other document with any other filing office necessary to memorialize this Release and to extinguish the Agent's rights and interest in the Trademarks.
- 3) This Release is governed by the internal laws of the State of Illinois.
- 4) This Release shall be binding upon the Agent and its successors and assigns and inures to the benefit of Grantor and its successors and assigns.
