NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

The rights and remedies of Lender with respect to the security interest granted herein are as set forth in the Loan Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Loan Agreement, the provisions of the Loan Agreement shall govern.


