**Release of Security Interest in Trademarks**

This **Release of Security Interest in Trademarks**, dated as of October 19, 2020 (this "Release"), is made by DELAWARE TRUST COMPANY, as Collateral Agent for the benefit of the Secured Creditors (in such capacity, the "Collateral Agent") in favor of GURU DENIM LLC, a California limited liability company, TRUE RELIGION APPAREL, INC., a Delaware corporation, TRUE RELIGION SALES, LLC, a Delaware limited liability company, TRLG INTERMEDIATE HOLDINGS, LLC, a Delaware limited liability company and TRLGCC SERVICES, LLC, a Virginia limited liability company (each a "Grantor" and collectively the "Grantors").

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of October 27, 2017 (as amended, restated, or modified from time to time, the "Trademark Security Agreement"), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 12, 2018 at Reel 6249 Frame 0031, the Grantors granted to the Collateral Agent, a security interest in and continuing lien on all of such Grantors' right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, those trademarks listed on Schedule I hereto;

WHEREAS, pursuant to that certain Trademark Security Agreement (Supplement No. 1), dated as of November 15, 2019 (as amended, restated, or modified from time to time, the "Supplemental Trademark Security Agreement"), which Supplemental Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 15, 2019 at Reel 6797 Frame 0313, the Grantors granted to the Collateral Agent, a security interest in and continuing lien on all of such Grantors' right, title and interest in, to and under the Trademark Collateral (as defined in the Supplemental Trademark Security Agreement), including, without limitation, those trademarks listed on Schedule II hereto;

WHEREAS, on April 13, 2020, the Grantors filed voluntary petitions for relief, commencing bankruptcy cases under chapter 11 of title 11 of the United States Code, in the United States Bankruptcy Court for the District of Delaware (the "Bankruptcy Court");

WHEREAS, on October 6, 2020, the Bankruptcy Court entered the *Findings of Fact, Conclusions of Law, and Order Confirming the Third Amended Joint Chapter 11 Plan of Reorganization of True Religion Apparel, Inc., and its Affiliated Debtors* (the "Confirmation Order"), which confirmed the *Third Amended Joint Chapter 11 Plan of Reorganization of True Religion Apparel, Inc., and its Affiliated Debtors* (the "Plan"); and

WHEREAS, this Release is intended to confirm, in accordance with the Plan and Confirmation Order, the release and termination of the Collateral Agent's lien on and security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement and the Supplemental Trademark Security Agreement), including, without limitation, the trademarks set forth on Schedule I and Schedule II hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent does hereby confirm and agree as follows:

Pursuant to the Plan and Confirmation Order, the Collateral Agent, its successors, legal representatives and assigns, hereby confirms (a) the release, discharge, termination and cancellation of any and all of its security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement and the Supplemental Trademark Security Agreement), including, without limitation, all United States registrations and applications for any of the following: trademarks, trade names, service marks, trade dress, logos, slogans, designs or fictitious business names, registered trademarks, trademark applications, service marks, registered service marks and service mark applications, whether or not registered, and with respect to any and all of the foregoing: (i) all registrations and applications therefor including, without limitation, the registrations and applications listed or required to be listed in Schedule I and Schedule II attached hereto, (ii) all extensions or renewals of any of the foregoing, (iii) all of the goodwill of the business connected with the use of and symbolized by any of the foregoing, (iv) all rights to sue or otherwise recover for any past, present and future infringement, dilution or other violation of any of the foregoing or for any injury to the related goodwill, (v) all proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect thereto, and (vi) all other rights of any kind accruing thereunder or pertaining thereto throughout the world, (b) that any and all right, title and interest of the Collateral Agent in, to or under the Trademark Collateral (as defined in the Trademark Security Agreement and the Supplemental Trademark Security Agreement) have been terminated and are ceased, and (c) the assignment, transfer and conveyance to Grantors of any and all right, title and interest it may have in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement and the Supplemental Trademark Security Agreement) (without recourse to or representation or warranty of any kind by the Collateral Agent).

The Collateral Agent authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office, and any other applicable government officer or authority, record this Release.

The Collateral Agent agrees to take all further actions, and provide the Grantors with any information, cooperation and assistance, including, without limitation, the execution and delivery of any and all further instruments, authorizations, documentation and release forms as any Grantor or its successor, assign or legal representative may reasonably request to confirm, effectuate and record this Release and the termination, cancellation and release of the security interest and any right, title or interest of the Collateral Agent in, to or under the Trademark Collateral (as defined in the Trademark Security Agreement and the Supplemental Trademark Security Agreement) at Grantors' sole cost and expense.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
