## RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is given on October 5, 2020, by WOODFOREST NATIONAL BANK, (the "Lender"), to the owner listed on Schedule A, attached hereto and incorporated herein by this reference, (the "Grantor").

WHEREAS, the Grantor and the Lender are party to (i) that certain Credit Agreement, by and among the Lender and the Grantor, dated as of July 30, 2020 (the "Credit Agreement"), (ii) that certain Guarantee and Security Agreement dated as of July 30, 2020 (the "Security Agreement") and (iii) that Trademark Security Agreement dated as of July 30, 2020 (the "Trademark Agreement");

WHEREAS, pursuant to the Security Agreement and the Trademark Agreement, the Grantor granted to the Lender, among other collateral, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under all United States trademarks, including those listed on the attached Schedule A (collectively, the "Trademarks");

WHEREAS, the Trademark Agreement was recorded in the United States Patent & Trademark Office on July 30, 2020 at reel/frame 7024/0316;

WHEREAS, the Grantor has performed all of its obligations under the Credit Agreement and accordingly the Lender has agreed to terminate and release its security interest in the Trademarks and retransfer and reassign to the Grantor without recourse all of the Lender's right, title and interest in and to those Trademarks.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby releases any security interest it may have in the Trademarks, and reassigns any and all right, title and interest it may have in and to those Trademarks without recourse to the relevant Grantor.

FURTHERMORE, the Lender hereby authorizes the Grantor and its authorized representatives to record this Release with the United States Patent and Trademark Office and agrees to take all further actions, and provide to the Grantor, all such cooperation and assistance (including without limitation the execution and delivery of any and all documents or other instruments) reasonably requested by the Lender, at the Lender's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

THIS RELEASE AND ANY CLAIM, CONTROVERSY OR DISPUTE ARISING HEREUNDER OR RELATED TO THIS RELEASE, WHETHER IN TORT, CONTRACT (AT LAW OR IN EQUITY) OR OTHERWISE, SHALL BE GOVERNED BY AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF CALIFORNIA.
