RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) dated as of October 13, 2020, is made by TRUIST BANK (as successor by merger to SUNTRUST BANK), as collateral agent (the “Collateral Agent”) in favor of ON DECK CAPITAL, INC. (“On Deck”) and ODX, LLC (“ODX” and, together with On Deck, each a “Grantor” and together the “Grantors”). Capitalized terms not defined herein shall have the meaning ascribed to them in the Trademark Security Agreement (as defined below) (or if not defined therein, in the Security Agreement referred to therein).

WHEREAS, pursuant to a Credit Agreement, dated as of January 28, 2019 (as may have been amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “Credit Agreement”), by and among On Deck, the lenders party thereto, Truist Bank (as successor by merger to SunTrust Bank), as administrative agent, and the Collateral Agent, each Grantor executed the Security Agreement, dated January 28, 2019 (as may have been amended, restated, amended and restated, supplemented and/or otherwise modified from time to time the “Security Agreement”) by and among Grantors, the subsidiaries of On Deck from time to time party thereto and Collateral Agent;

WHEREAS, pursuant to the Security Agreement, each Grantor executed and delivered a Trademark Security Agreement, dated January 28, 2019, in favor of the Collateral Agent (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office on January 28, 2019 at Reel/Frame 6540/0559;

WHEREAS, pursuant to the Trademark Security Agreement, each Grantor granted to the Collateral Agent, its successors and permitted assigns, for the benefit of the Secured Parties, a security interest in all of such Grantor’s Trademark Collateral, including the Trademarks listed on Schedule 1 attached hereto; and

WHEREAS each Grantor has requested that the Collateral Agent now terminate and release its security interest in the Trademark Collateral.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Collateral Agent hereby, without any representation and/or warranty of any kind and without any recourse terminates the Trademark Security Agreement and terminates, cancels and releases its security interest in the Trademark Collateral.

Each Grantor (and any successor to such Grantor, including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral) is hereby authorized to record this Release with the United States Patent and Trademark Office.
