RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of October 23, 2020 (the "Release"), is made by SENIOR CREDIT (UWF) LLC, in its capacity as collateral agent for the secured parties (in such capacity, together with its successors and permitted assigns, the "Collateral Agent"), in favor of CONCEPTS IN DATA MANAGEMENT INC., an Ontario, Canada corporation, LONE WOLF REAL ESTATE TECHNOLOGIES INC., a company organized under the laws of British Columbia, LONE WOLF REAL ESTATE TECHNOLOGIES, INC., a Delaware corporation, RE FORMSNET, LLC, a Delaware limited liability company, WHERETOLIVE.COM, INC., a Delaware corporation, and WOLFPACK IP CO., a Delaware corporation (each a "Pledgor" and collectively, the "Pledgors"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Security Agreement, or if not defined therein, in the Credit Agreement.

WITNESSETH

WHEREAS, the Pledgors and the Collateral Agent are parties to that certain Security Agreement, dated as of June 14, 2019 (as amended, restated, amended and restated, supplemented, waived, renewed, replaced or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Pledgors executed the Trademark Security Agreement, dated as of June 14, 2019 (the "<u>Trademark Security Agreement</u>") and recorded with the U.S. Patent and Trademark Office on June 14, 2019 at Reel/Frame Nos. 6670/0079, 6702/0868, 6669/0973, 6669/0982, 6670/0009, and 6670/0037, pursuant to which the Pledgors pledged and granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in (subject to Permitted Liens) all of the right, title and interest of Pledgors in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, the Pledgors have requested that the Collateral Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby states as follows:

- 1. Release of Security Interest. The Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Pledgors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.
- 2. <u>Governing Law.</u> This Release shall be construed in accordance with and governed by the law of the State of New York. The terms of Section 10.09(b) and Section 10.10 of the Credit Agreement are incorporated herein mutatis mutandis.
