**RELEASE OF NOTICE OF GRANT OF SECURITY
INTEREST IN PATENTS AND TRADEMARKS**

This Release of Notice of Grant of Security Interest in Patents and Trademarks (the "Release") is made and effective as of October 28, 2020 and granted by People's United Bank, National Association f/k/a People's United Bank, a national banking association (the "Lender"), and in favor of Micro Precision, LLC, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Loan and Security Agreement dated as of September 16, 2011, by and among, Grantor and Lender, Grantor and Lender entered into that certain Notice of Grant of Security Interest in Patents and Trademarks dated as of September 16, 2011 (the "**IP Security Agreement**"), which was recorded with the United States Patent and Trademark Office at Reel/Frame 004625/0823 and Reel/Frame 026930/0128 and recorded with Canadian Intellectual Property Office on against Registration No. TMA119267 (as reflected on Schedule A);

WHEREAS, the Grantor collaterally assigned to the Lender a security interest in all of the Grantor's right, title and interest in, to and under the patents and trademarks identified in Schedule A attached hereto (the "**Intellectual Property**"); and

WHEREAS, the Lender has agreed to release its security interest in the Intellectual Property and terminate such IP Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby states as follows:

1. Release of IP Security Interest. Lender hereby terminates the IP Security Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the IP Security Agreement in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in or to the Intellectual Property.

2. Further Assurances. Lender agrees, at the Grantor's expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to effectuate or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Connecticut, without giving effect to any choice or conflict of law provision or rule (whether of the State of Connecticut or any other jurisdiction).
