TRADEMARK ASSIGNMENT

This Trademark Assignment (the “*Assignment*”), effective as of October 15, 2020 (the “*Effective Date*”) is entered into by and between **COSETTE PHARMACEUTICALS, INC.**, a Delaware corporation (“*Assignee*”) and **HORIZON THERAPEUTICS IRELAND DAC**, an Irish designated activity company, with its principal place of business located at 1 Burlington Road, Connaught House, 1st Floor, Dublin, Ireland D04 C5Y6 (“*Assignor*”). Assignee and Assignor are referred to individually as a “*Party*,” and collectively in this Assignment as, the “*Parties*.”

WHEREAS, Assignor is the registered owner of the U.S. Trademark Registration Number 1,508,914, for the mark MIGERGOT (the “*Trademark*”);

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of June 28, 2019 (the “*Purchase Agreement*”), by and between HZNP Limited (the “*Affiliate of Assignor*”) and Assignee, the parties thereto agreed to effect the acquisition of certain assets from the Affiliate of Assignor, upon the terms and subject to the conditions set forth in the Purchase Agreement;

WHEREAS, pursuant to the Purchase Agreement, the Affiliate of Assignor and the Assignee duly executed an Intellectual Property Assignment, dated as of June 28, 2019, which included assignment of the Trademark;

WHEREAS, pursuant to an intercompany agreement in connection with an internal reorganization, the Affiliate of Assignor assigned its residual rights in the Trademark to Assignor; and

WHEREAS, Assignor desires to transfer to Assignee all of Assignor’s right, title and interest in and to the Trademark and the goodwill associated therewith as of the Effective Date.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignor and Assignee, the Parties agree as follows:

1. Assignor hereby irrevocably transfers and assigns to Assignee all of Assignor’s right, title and interest in and to the Trademark and the good will associated therewith.
