**RELEASE OF SECURITY AGREEMENT AND GRANT OF SECURITY  
INTEREST IN PATENTS AND TRADEMARKS**

This Release of Security Agreement and Grant of Security Interest in Patents and Trademarks (the “**Release**”) is made and effective as of October 23, 2020 and granted by Connecticut Growth Fund II, Limited Partnership, a Connecticut limited partnership, as collateral agent for the purchasers (the “**Collateral Agent**”), and in favor of Micro Precision, LLC, a Delaware limited liability company (the “**Grantor**”).

**WHEREAS**, pursuant to the terms and conditions of that certain Senior Subordinated Note and Warrant Purchase Agreement dated as of July 25, 2019, by and among, Grantor, Collateral Agent and other parties thereto, (i) Grantor and Collateral Agent entered into that certain Patent Security Agreement dated as of July 25, 2019 (the “**Patent Security Agreement**”), which was recorded with the United States Patent and Trademark Office on July 26, 2019 at Reel/Frame: 049868/0411 and (ii) Grantor and Collateral Agent entered into that certain Trademark Security Agreement dated as of July 25, 2019 (the “**Trademark Security Agreement**” and together with the Patent Security Agreement, collectively known as the “**IP Security Agreements**”), which was recorded with the United States Patent and Trademark Office on July 26, 2019 at Reel/Frame: 006704/0377 and recorded with Canadian Intellectual Property Office on October 1, 2019 against Registration No. TMA119267 (as reflected on Schedule A); and

**WHEREAS**, pursuant to the IP Security Agreements, the Grantor collaterally assigned to the Collateral Agent a security interest in all of the Grantor’s right, title and interest in, to and under the patents and trademarks identified in Schedule A attached hereto (the “**Intellectual Property**”); and

**WHEREAS**, the Collateral Agent has agreed to release its security interest in the Intellectual Property and terminate such IP Security Agreements.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby states as follows:

1. Release of IP Security Interest. Collateral Agent hereby terminates the IP Security Agreements and terminates, releases and discharges any and all security interests that it has pursuant to the IP Security Agreements in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in or to the Intellectual Property.

2. Further Assurances. Collateral Agent agrees, at the Grantor’s expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to effectuate or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Connecticut, without giving effect to any choice or conflict of law provision or rule (whether of the State of Connecticut or any other jurisdiction).

**IN WITNESS WHEREOF**, the Collateral Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date first above written.
